- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

1. Use the spray extraction process sometimes referred to as “steam cleaning” as it is the preferred (recommended) method by carpet manufactures for removing dirt and bacteria in the process of cleaning.

- The carpet must be thoroughly vacuumed by a heavy -duty vacuum cleaner with a power-driven brush or beater.
- Chemical is sprayed on and left to bond with the soil/dirt.
- Steam is injected into the carpet with a high- pressure jet spray, i.e. steam infused into carpet, loosens all dirt as the steam turns to water.
- And finally, the water is vacuumed out.

2. Equipment to be used must be in good working condition and comply with Health and Safety Regulations of the Occupational Health and Safety Act of 1993.

3. Use the correct cleaning agent in the correct quantity to avoid sticky residue which will accelerate re-soiling.

4. Chemicals and detergents should be effectively rinsed from the carpet.

5. The service provider will be requested to render the service within the time frame that will be identified by Auxiliary services, so it is highly advisable that the service provider be fully equipped and have at least a minimum of seven employees to fulfill the service within the specified time frame schedule.

6. The service provider must be able to deal with over-wetting of carpet as it can result in:

- a) The growth of mold and a musty smell which may sensitize respiratory.
- b) Slipping and falling by occupants/ employees resulting in injuries
- c) Water stains and brown stains from the carpet backing.
- d) Shrinking or cracking, which in extreme cases will destroy the carpets.

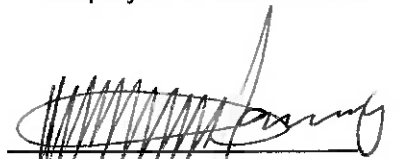
7. An industrial- strength blower must be used to dry carpet faster.

8. Special requirements on Chemicals and detergents to be used must be:

- a) Classified, labelled, and provided with safety data sheets as per the provisions of Hazardous Chemical Agents Regulations (HCAR) of 2021 of the Occupational Safety and Health Act of 1993.
- b) Globally Harmonized System (GHS) compliant (That is GHS for classification and labelling of hazardous chemical agents incorporated in the HCAR of 2021).

9. The appointed service provider must:

- (a) Be familiar with Agricultural Remedies (chemicals) that are **banned or restricted** for use in the Republic of South Africa as per the list gazetted in 2017 and reviewed in 2024.
- (b) Ensure his/her employees wear the necessary Personal Protective Equipment's (PPE) while performing they're duties within departmental premises.
- (c) Ensure the protection of the health and safety of departmental employee and clients, protection of the workplace and the environment in general.
- (d) Have a letter of good standing with the Compensation Commissioner of the Department of Employment and Labour.
