**FIRST NOTICE TO TENDERERS**

Following the compulsory site inspection held on Thursday, the 14<sup>th</sup> of August 2025, the following information is set out for clarification and forms part of the tender document.

**1. ALTERATION TO/AMENDMENTS:**

**C.2: Tenderers Obligations**, clause C.2.1.3, Table 1 & 2: Experience Requirement and Works of a Similar Nature is depicted as follows:

**Table 1: Experience Requirement**

Contract(s), with works of a similar nature, within the past **5 years**, where the combined value of completed work is at least 70% of the tender value submitted for this tender on the **Form of Offer (C1.1.1)**.

A minimum of **5 contracts**, with works of a similar nature, within the past **5 years**, each with a value of 70% of the tender value submitted for this tender on the **Form of Offer (C1.1.1)**.

**Table 2: Works of a Similar Nature**

**Provision of Stormwater infrastructure (Repairs or upgrades of stormwater infrastructure system)**

Projects of a similar nature that will be considered will be one, or a combination of, the following types of projects:

- Retaining walls (gabion protection works).
- Reinforced concrete construction.
- Reinforced concrete repairs (spalling, member replacement, use of specialist products etc).
- Concrete works (sidewalks, V-drains, etc)
- Installation of stormwater infrastructure (Stormwater HDPE or Concrete pipes, pipe culverts, manholes and inlets)
- Reinforced concrete apron slabs and wing walls.

**Table 1 & 2 have been amended to the following:**

**Table 1: Experience Requirement**

A minimum of **5 contracts**, with works of a similar nature, within the past **5 years**, each project submitted with a value of 70% of the tender value submitted for this tender on the **Form of Offer (C1.1.1)**.

**Table 2: Works of a Similar Nature**

**Provision of Stormwater Infrastructure (Repairs or upgrades of stormwater infrastructure system)**

Projects of a similar nature that will be considered will be one, or a combination of, the following types of projects:

- Retaining walls (gabion protection works or reinforced concrete wall).
- Installation of stormwater infrastructure (Stormwater HDPE or Concrete pipes, pipe culverts, manholes and inlets)
- Reinforced concrete apron slabs and wing walls.
- **Each** project submitted must consist of a minimum of three of the following elements: Bulk earthworks, kerb and channelling, concrete/asphalt sidewalks, proving existing services, roadway layer works, and asphalt roadway surfacing.
- Projects that are **excluded** are road rehabilitation projects, road maintenance projects, and the construction of gravel roads.

**Important changes to note:**

1. The works of similar nature have been amended to correct the erroneous requirements of the original tender document. The requirements of the original tender document align with a structural scope of works.
2. The amended table 1 & 2 consists of requirements which align with the stormwater infrastructure required for the project. In terms of C.2: Tenderers Obligations, clause C.2.1.3, Table 1 & 2, tenderers are to **only** submit the projects which align with the requirements of the amended Table 1 & 2.
