- The proposed project methodology implementation Plan.

Tenders will be evaluated using the 80/20 principles of the Preferential Procurement Policy Framework Act, No. 5, 2000 with its 2017 Regulations and functionality - Organisational Capacity, Capabilities, and Experience in the Implementation, Maintenance of SDWAN services (35 Points), Project methodology implementation plan (20 Points), Locality of the bidder (15 Points), Key Personnel (30 Points). Proposals that fail to achieve a minimum score of 70% will not qualify for further evaluation.
