Scope Clarification Meeting

PetroSA has scheduled a **Virtual (MS Teams) scope clarification meeting** at **11h00** on **27 May 2025**.

Should the Tenderer wish to attend it must inform the PetroSA representative by **15H00** on **26 May 2025** so that We can send you the link.

Suppliers are advised to attend the scope clarification meeting in order to acquaint themselves with the nature of the supply required and local conditions, as no claims will be entertained in this regard once the tender has been awarded. **The scope clarification meeting will give Suppliers an opportunity to seek clarification of the tender documentation to facilitate completion thereof.** Non-attendance at the above meeting/inspection will not disqualify a tender.

TRANSPORT SECTOR B-BBEE REQUIREMENT

The B-BBEE qualification requirement for this tender is as follows:

- EME's i.e. Turnover is below R5 million - A Certificate from a SANAS Accredited Agency or an Auditors Letter which confirms that the Revenue of the Transport company was less than R5 million in their latest financial period and that it should also confirm the percentage of their shareholding that is held by Black People and Black Women,
- QSE's i.e. where the Turnover of the Transport company is between R5 million and R35 million - only a certificate issued by a SANAS Accredited Agency and
- Generics - Turnover above R35 million - Only a Certificate issued by a SANAS Accredited Agency.

NB: An Affidavit is not acceptable for Transport Companies

A valid SANAS accredited B-BBEE certificate for Transport Companies must also indicate the applicable scorecard as Road Freight Transport Sector.
