2. TENDER SUBMISSION

Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

a) The Transnet e-Tender Submission Portal can be accessed as follows:

- Click on "ADVERTISED TENDERS" to view advertised tenders;
- Click on "SIGN IN/REGISTER – for bidder to register their information (must fill in all mandatory information);
- Click on "SIGN IN/REGISTER" - to sign in if already registered;
- Toggle (click to switch) the "Log an Intent" button to submit a bid;
- Submit bid documents by uploading them into the system against each tender selected.
- **Tenderers are required to ensure that electronic bid submissions are done at least a day before the closing date to prevent issues which they may encounter due to their internet speed, bandwidth or the size of the number of uploads they are submitting. Transnet will not be held liable for any challenges experienced by bidders as a result of the technical challenges. Please do not wait for the last hour to submit. A Tenderer can upload 30mb per upload and multiple uploads are permitted.**

b) The tender offers to this tender will be opened as soon as possible after the closing date and time. Transnet shall not, at the opening of tenders, disclose to any other company any confidential details pertaining to the Tender Offers / information received, i.e. pricing, delivery, etc. The names and locations of the Tenderers will be divulged to other Tenderers upon request.

- c) Submissions must not contain documents relating to any Tender other than that shown on the submission.

3. CONFIDENTIALITY

All information related to this RFQ is to be treated with strict confidentiality. In this regard Tenderers are required to certify that they have acquainted themselves with the Non-Disclosure Agreement. All information related to a subsequent contract, both during and after completion thereof, will be treated with strict confidence. Should the need however arise to divulge any information gleaned from provision of the Works, which is either directly or indirectly related to Transnet's business, written approval to divulge such information must be obtained from Transnet.

4. DISCLAIMERS

Tenderers are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this Tender and/or its receipt of a tender offer. In particular, please note that Transnet reserves the right to:

- 4.1. Award the business to the highest scoring Tenderer/s unless objective criteria justify the award to another tenderer.
- 4.2. Not necessarily accept the lowest priced tender or an alternative Tender;
- 4.3. Go to the open market if the quoted rates (for award of work) are deemed unreasonable;
- 4.4. Should the Tenderers be awarded business on strength of information furnished by the Tenderer, which after conclusion of the contract is proved to have been incorrect, Transnet reserves the right to terminate the contract;
- 4.5. Request audited financial statements or other documentation for the purposes of a due diligence exercise;
- 4.6. Not accept any changes or purported changes by the Tenderer to the tender rates after the closing date;
- 4.7. Verify any information supplied by a Tenderer by submitting a tender, the Tenderer/s hereby irrevocably grant the necessary consent to the Transnet to do so;

- 4.12. Transnet reserves the right to perform a risk analysis on the preferred tenderer to ascertain if any of the following might present an unacceptable commercial risk to the employer:
 - *unduly high or unduly low tendered rates or amounts in the tender offer;*
 - *contract data of contract provided by the tenderer; or*
 - *the contents of the tender returnables which are to be included in the contract.*

5. Transnet will not reimburse any Tenderer for any preparatory costs or other work performed in connection with this Tender, whether or not the Tenderer is awarded a contract.

T1.2 TENDER DATA

The conditions of tender are the Standard Conditions of Tender as contained in Annex C of the CIDB Standard for Uniformity in Engineering and Construction Works Contracts. The Standard for Uniformity in Construction Procurement was first published in Board Notice 62 of 2004 in Government Gazette No 26427 of 9 June 2004. It was subsequently amended in Board Notice 67 of 2005 in Government Gazette No 28127 of 14 October 2005, Board Notice 93 of 2006 in Government Gazette No 29138 of 18 August 2006, Board Notice No 9 of 2008 in Government Gazette No 31823 of 30 January 2009, Board Notice 86 of 2010 in Government Gazette No 33239 of 28 May 2010, Board Notice 136 of 2015 in Government Gazette 38960 of 10 July 2015 and Board Notice 423 of 2019 in Government Gazette No 42622 of 8 August 2019.

This edition incorporates the amendments made in Board Notice 423 of 2019 in Government Gazette 42622 of 8 August 2019. (see www.cidb.org.za).

3. Stage Three - Functionality: Only those tenderers who obtain the minimum qualifying score for functionality will be evaluated further in terms of price and the applicable preference point system. The minimum qualifying for score for functionality is **70** points.

The evaluation criteria for measuring functionality and the points for each criteria and, if any, each sub-criterion are as stated in C.3.11.3 below.

Any tenderer that fails to meet the stipulated pre-qualifying criteria will be regarded as an unacceptable tender.

C.2.7 The arrangements for a compulsory clarification meeting are as stated in the Tender Notice and Invitation to Tender. **Tenderers must complete and sign the attendance register.** Addenda will be issued to and tenders will only be received from those tendering entities including those entities that intends forming a joint venture appearing on the attendance register.

Each evaluation criteria will be assessed in terms of scores of 0, 20, 40, 60, 80 or 100. The scores of each of the evaluators will be averaged, weighted and then totalled to obtain the final score for functionality, unless scored collectively. (See CIDB Inform Practice Note #9).

Note: Any tender not complying with the above mentioned requirements, will be regarded as non-responsive and will therefore not be considered for further evaluation. This note must be read in conjunction with Clause C.2.1.

C.3.13 Tender offers will only be accepted if:

1. The tenderer or any of its directors/shareholders is not listed on the Register of Tender Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector;
2. the tenderer does not appear on Transnet’s list for restricted tenderers and National Treasury’s list of Tender Defaulters;
3. the tenderer has fully and properly completed the Compulsory Enterprise Questionnaire and there are no conflicts of interest which may impact on the tenderer’s ability to perform the contract in the best interests of the Employer or potentially compromise the tender process and persons in the employ of the state.
4. Transnet reserves the right to award the tender to the tenderer who scores the highest number of points overall, unless there are **objective criteria** which will justify the award of the tender to another tenderer. Objective criteria include but are not limited to the outcome of a due diligence exercise to be conducted. The due diligence exercise may take the following factors into account inter alia; the tenderer:

- 3.4 The Tenderer/Service Provider/Contractor will not enter into any illegal or dishonest agreement or understanding, whether formal or informal with other Tenderers/Service Providers/Contractors. This applies in particular to certifications, submissions or non-submission of documents or actions that are restrictive or to introduce cartels into the tendering process.
- 3.5 The Tenderer/Service Provider/Contractor will not commit any criminal offence under the relevant anti-corruption laws of South Africa or any other country. Furthermore, the Tenderer/Service Provider/Contractor will not use for illegitimate purposes or for restrictive purposes or personal gain, or pass on to others, any information provided by Transnet as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
- 3.6 A Tenderer/Service Provider/Contractor of foreign origin shall disclose the name and address of its agents or representatives in South Africa, if any, involved directly or indirectly in the registration or tendering process. Similarly, the Tenderer / Service Provider / Contractor of South African nationality shall furnish

the name and address of the foreign principals, if any, involved directly or indirectly in the registration or tendering process.

- 3.7 The Tenderer/Service Provider/Contractor will not misrepresent facts or furnish false or forged documents or information in order to influence the tendering process to the advantage of the Tenderer/Service Provider/Contractor or detriment of Transnet or other competitors.
- 3.8 Transnet may require the Tenderer/Service Provider/Contractor to furnish Transnet with a copy of its code of conduct. Such code of conduct must address the compliance programme for the implementation of the code of conduct and reject the use of bribes and other dishonest and unethical conduct.
- 3.9 The Tenderer/Service Provider/Contractor will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 3.10 The Tenderer/Service Provider/Contractor confirms that they will uphold the ten principles of the United Nations Global Compact (UNGC) in the fields of Human Rights, Labour, Anti-Corruption and the Environment when undertaking business with Transnet as follows:
- a) Human Rights
- Principle 1: Businesses should support and respect the protection of internationally proclaimed human rights; and
 - Principle 2: make sure that they are not complicit in human rights abuses.
- b) Labour
- Principle 3: Businesses should uphold the freedom of association and the effective recognition of the right to collective bargaining;
 - Principle 4: the elimination of all forms of forced and compulsory labour;
 - Principle 5: the effective abolition of child labour; and
 - Principle 6: the elimination of discrimination in respect of employment and occupation.
- c) Environment
- Principle 7: Businesses should support a precautionary approach to environmental challenges;
 - Principle 8: undertake initiatives to promote greater environmental responsibility; and

- Principle 9: encourage the development and diffusion of environmentally friendly technologies.

d) Anti-Corruption

- Principle 10: Businesses should work against corruption in all its forms, including extortion and bribery.

4 INDEPENDENT TENDERING

4.1 For the purposes of that Certificate in relation to any submitted Tender, the Tenderer declares to fully understand that the word "competitor" shall include any individual or organisation, other than the Tenderer, whether or not affiliated with the Tenderer, who:

- a) has been requested to submit a Tender in response to this Tender invitation;
- b) could potentially submit a Tender in response to this Tender invitation, based on their qualifications, abilities or experience; and
- c) provides the same Goods and Services as the Tenderer and/or is in the same line of business as the Tenderer.

4.2 The Tenderer has arrived at his submitted Tender independently from, and without consultation, communication, agreement or arrangement with any competitor. However communication between partners in a joint venture or consortium will not be construed as collusive tendering.

4.3 In particular, without limiting the generality of paragraph 5 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:

- a) prices;
- b) geographical area where Goods or Services will be rendered [market allocation];
- c) methods, factors or formulas used to calculate prices;
- d) the intention or decision to submit or not to submit, a Tender;
- e) the submission of a Tender which does not meet the specifications and conditions of the RFQ; or
- f) tendering with the intention of not winning the Tender.

4.4 In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the Goods or Services to which his/her tender relates.

- 4.5 The terms of the Tender as submitted have not been, and will not be, disclosed by the Tenderer, directly or indirectly, to any competitor, prior to the date and time of the official Tender opening or of the awarding of the contract.
- 4.6 Tenderers are aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to Tenders and contracts, Tenders that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and/or may be reported to the National Prosecuting Authority [**NPA**] for criminal investigation and/or may be restricted from conducting business with the public sector for a period not exceeding 10 [ten] years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
- 4.7 Should the Tenderer find any terms or conditions stipulated in any of the relevant documents quoted in the Tender unacceptable, it should indicate which conditions are unacceptable and offer alternatives by written submission on its company letterhead, attached to its submitted Tender. Any such submission shall be subject to review by Transnet's Legal Counsel who shall determine whether the proposed alternative(s) are acceptable or otherwise, as the case may be.

5 DISQUALIFICATION FROM TENDERING PROCESS

- 5.1 If the Tenderer/Service Provider/Contractor has committed a transgression through a violation of section 3 of this Integrity Pact or in any other form such as to put its reliability or credibility as a Tenderer/Service Provider/Contractor into question, Transnet may reject the Tenderer's / Service Provider's / Contractor's application from the registration or tendering process and remove the Tenderer/Service Provider/Contractor from its database, if already registered.
- 5.2 If the Tenderer/Service Provider/Contractor has committed a transgression through a violation of section 3, or any material violation, such as to put its reliability or credibility into question. Transnet may after following due procedures and at its own discretion also exclude the Tenderer/Service Provider /Contractor from future tendering processes. The imposition and duration of the exclusion will be determined by the severity of the transgression. The severity will be determined by the circumstances of the case, which will include amongst others the number of transgressions, the position of the transgressors within the company hierarchy of the Tenderer/Service Provider/Contractor and the amount of the damage. The exclusion will be imposed for up to a maximum of 10 (ten) years. However, Transnet reserves the right to impose a longer period of exclusion, depending on the gravity of the misconduct.

- 5.3 If the Tenderer/Service Provider/Contractor can prove that it has restored the damage caused by it and has installed a suitable corruption prevention system, or taken other remedial measures as the circumstances of the case may require, Transnet may at its own discretion revoke the exclusion or suspend the imposed penalty.

6 TRANSNET'S LIST OF EXCLUDED TENDERERS (BLACKLIST)

- 6.1 The process of restriction is used to exclude a company/person from conducting future business with Transnet and other organs of state for a specified period. No Tender shall be awarded to a Tenderer whose name (or any of its members, directors, partners or trustees) appear on the Register of Tender Defaulters kept by National Treasury, or who have been placed on National Treasury's List of Restricted Suppliers. Transnet reserves the right to withdraw an award, or cancel a contract concluded with a Tenderer should it be established, at any time, that a tenderer has been restricted with National Treasury by another government institution.
- 6.2 All the stipulations on Transnet's restriction process as laid down in Transnet's Supply Chain Policy and Procurement Procedures Manual (CPM included) are included herein by way of reference. Below follows a condensed summary of this restriction procedure.
- 6.3 On completion of the restriction procedure, Transnet will submit the restricted entity's details (including the identity number of the individuals and registration number of the entity) to National Treasury for placement on National Treasury's Database of Restricted Suppliers for the specified period of exclusion. National Treasury will make the final decision on whether to restrict an entity from doing business with any organ of state for a period not exceeding 10 years and place the entity concerned on the Database of Restricted Suppliers published on its official website.
- 6.4 The decision to restrict is based on one of the grounds for restriction. The standard of proof to commence the restriction process is whether a "*prima facie*" (i.e. on the face of it) case has been established.
- 6.5 Depending on the seriousness of the misconduct and the strategic importance of the Goods/Services, in addition to restricting a company/person from future business, Transnet may decide to terminate some or all existing contracts with the company/person as well.
- 6.6 A Service Provider or Contractor to Transnet may not subcontract any portion of the contract to a blacklisted company.

- 6.7 Grounds for blacklisting include: If any person/Enterprise which has submitted a Tender, concluded a contract, or, in the capacity of agent or subcontractor, has been associated with such Tender or contract:
- a) Has, in bad faith, withdrawn such Tender after the advertised closing date and time for the receipt of Tenders;
 - b) has, after being notified of the acceptance of his Tender, failed or refused to sign a contract when called upon to do so in terms of any condition forming part of the Tender documents;
 - c) has carried out any contract resulting from such Tender in an unsatisfactory manner or has breached any condition of the contract;
 - d) has offered, promised or given a bribe in relation to the obtaining or execution of the contract;
 - e) has acted in a fraudulent or improper manner or in bad faith towards Transnet or any Government Department or towards any public body, Enterprise or person;
 - f) has made any incorrect statement in a certificate or other communication with regard to the Local Content of his Goods or his B-BBEE status and is unable to prove to the satisfaction of Transnet that:
 - (i) he made the statement in good faith honestly believing it to be correct; and
 - (ii) before making such statement he took all reasonable steps to satisfy himself of its correctness;
 - g) caused Transnet damage, or to incur costs in order to meet the contractor's requirements and which could not be recovered from the contractor;
 - h) has litigated against Transnet in bad faith.
- 6.8 Grounds for blacklisting include a company/person recorded as being a company or person prohibited from doing business with the public sector on National Treasury's database of Restricted Service Providers or Register of Tender Defaulters.
- 6.9 Companies associated with the person/s guilty of misconduct (i.e. entities owned, controlled or managed by such persons), any companies subsequently formed by the person(s) guilty of the misconduct and/or an existing company where such person(s) acquires a controlling stake may be considered for

blacklisting. The decision to extend the blacklist to associated companies will be at the sole discretion of Transnet.

7 PREVIOUS TRANSGRESSIONS

- 7.1 The Tenderer/Service Provider/Contractor hereby declares that no previous transgressions resulting in a serious breach of any law, including but not limited to, corruption, fraud, theft, extortion and contraventions of the Competition Act 89 of 1998, which occurred in the last 5 (five) years with any other public sector undertaking, government department or private sector company that could justify its exclusion from its registration on the Tenderer's/Service Provider's/Contractor's database or any tendering process.
- 7.2 If it is found to be that the Tenderer/Service Provider/Contractor made an incorrect statement on this subject, the Tenderer/Service Provider/Contractor can be rejected from the registration process or removed from the Tenderer/Service Provider/Contractor database, if already registered, for such reason (refer to the Breach of Law Returnable Form contained in the document.)

8 SANCTIONS FOR VIOLATIONS

- 8.1 Transnet shall also take all or any one of the following actions, wherever required to:
- a) Immediately exclude the Tenderer/Service Provider/Contractor from the tendering process or call off the pre-contract negotiations without giving any compensation the Tenderer/Service Provider/Contractor. However, the proceedings with the other Tenderer/Service Provider/Contractor may continue;
 - b) Immediately cancel the contract, if already awarded or signed, without giving any compensation to the Tenderer/Service Provider/Contractor;
 - c) Recover all sums already paid by Transnet;
 - d) Encash the advance bank guarantee and performance bond or warranty bond, if furnished by the Tenderer/Service Provider/Contractor, in order to recover the payments, already made by Transnet, along with interest;
 - e) Cancel all or any other contracts with the Tenderer/Service Provider/Contractor; and
 - f) Exclude the Tenderer/Service Provider/Contractor from entering into any Tender with Transnet in future.

9 CONFLICTS OF INTEREST

- 9.1 A conflict of interest includes, inter alia, a situation in which:
- a) A Transnet employee has a personal financial interest in a tendering / supplying entity; and

b) A Transnet employee has private interests or personal considerations or has an affiliation or a relationship which affects, or may affect, or may be perceived to affect his / her judgment in action in the best interest of Transnet, or could affect the employee's motivations for acting in a particular manner, or which could result in, or be perceived as favouritism or nepotism.

9.2 A Transnet employee uses his / her position, or privileges or information obtained while acting in the capacity as an employee for:

- a) Private gain or advancement; or
- b) The expectation of private gain, or advancement, or any other advantage accruing to the employee must be declared in a prescribed form.

Thus, conflicts of interest of any Tender committee member or any person involved in the sourcing process must be declared in a prescribed form.

9.3 If a Tenderer/Service Provider/Contractor has or becomes aware of a conflict of interest i.e. a family, business and / or social relationship between its owner(s)/ member(s)/director(s)/partner(s)/shareholder(s) and a Transnet employee/ member of Transnet's Board of Directors in respect of a Tender which will be considered for the Tender process, the Tenderer/Service Provider/ Contractor:

- a) must disclose the interest and its general nature, in the Request for Proposal ("RFX") declaration form; or
- b) must notify Transnet immediately in writing once the circumstances has arisen.

9.4 The Tenderer/Service Provider/Contractor shall not lend to or borrow any money from or enter into any monetary dealings or transactions, directly or indirectly, with any committee member or any person involved in the sourcing process, where this is done, Transnet shall be entitled forthwith to rescind the contract and all other contracts with the Tenderer/Service Provider/Contractor.

10 DISPUTE RESOLUTION

10.1 Transnet recognises that trust and good faith are pivotal to its relationship with its Tenderer / Service Provider / Contractor. When a dispute arises between Transnet and its Tenderer / Service Provider / Contractor, the parties should use their best endeavours to resolve the dispute in an amicable manner, whenever possible. Litigation in bad faith negates the principles of trust and good faith on which commercial relationships are based. Accordingly, following a blacklisting process as mentioned in paragraph 6 above, Transnet will not do business with a company that litigates against it in bad faith or is involved in any action that reflects bad faith on its part. Litigation in bad faith includes, but is not limited to the following instances:

- a) **Vexatious proceedings:** these are frivolous proceedings which have been instituted without proper grounds;



- b) **Perjury:** where a Tenderer / Service Provider / Contractor make a false statement either in giving evidence or on an affidavit;
- c) **Scurrilous allegations:** where a Tenderer / Service Provider / Contractor makes allegations regarding a senior Transnet employee which are without proper foundation, scandalous, abusive or defamatory; and
- d) **Abuse of court process:** when a Tenderer / Service Provider / Contractor abuses the court process in order to gain a competitive advantage during a Tender process.

11 GENERAL

- 11.1 This Integrity Pact is governed by and interpreted in accordance with the laws of the Republic of South Africa.
- 11.2 The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the law relating to any civil or criminal proceedings.
- 11.3 The validity of this Integrity Pact shall cover all the tendering processes and will be valid for an indefinite period unless cancelled by either Party.
- 11.4 Should one or several provisions of this Integrity Pact turn out to be invalid the remainder of this Integrity Pact remains valid.
- 11.5 Should a Tenderer/Service Provider/Contractor be confronted with dishonest, fraudulent or corruptive behaviour of one or more Transnet employees, Transnet expects its Tenderer/Service Provider/Contractor to report this behaviour directly to a senior Transnet official/employee or alternatively by using Transnet's "Tip-Off Anonymous" hotline number 0800 003 056, whereby your confidentiality is guaranteed.

The Parties hereby declare that each of them has read and understood the clauses of this Integrity Pact and shall abide by it. To the best of the Parties' knowledge and belief, the information provided in this Integrity Pact is true and correct.

T2.2-19: Supplier Code of Conduct

Transnet SOC Limited aims to achieve the best value for money when buying or selling goods and obtaining services. This however must be done in an open and fair manner that supports and drives a competitive economy. Underpinning our process are several acts and policies that any supplier dealing with Transnet must understand and support. These are:

- The Transnet Procurement Policy – A guide for Tenderers.
- Section 217 of the Constitution - the five pillars of Public PSCM (Procurement and Supply Chain Management): fair, equitable, transparent, competitive and cost effective;
- The Public Finance Management Act (PFMA);
- The Broad Based Black Economic Empowerment Act (BBBEE)
- The Prevention and Combating of Corrupt Activities Act (PRECCA); and
- The Construction Industry Development Board Act (CIDB Act).

This code of conduct has been included in this contract to formally appraise Transnet Suppliers of Transnet's expectations regarding behaviour and conduct of its Suppliers.

Prohibition of Bribes, Kickbacks, Unlawful Payments, and Other Corrupt Practices

Transnet is in the process of transforming itself into a self-sustaining State Owned Enterprise, actively competing in the logistics industry. Our aim is to become a world class, profitable, logistics organisation. As such, our transformation is focused on adopting a performance culture and to adopt behaviours that will enable this transformation.

1. Transnet SOC Limited will not participate in corrupt practices. Therefore, it expects its suppliers to act in a similar manner.

- Transnet and its employees will follow the laws of this country and keep accurate business records that reflect actual transactions with, and payments to, our suppliers.
- Employees must not accept or request money or anything of value, directly or indirectly, from suppliers.
- Employees may not receive anything that is calculated to:
 - Illegally influence their judgement or conduct or to ensure the desired outcome of a sourcing activity;

- Win or retain business or to influence any act or decision of any person involved in sourcing decisions; or
- Gain an improper advantage.
- There may be times when a supplier is confronted with fraudulent or corrupt behaviour of Transnet employees. We expect our Suppliers to use our "Tip-offs Anonymous" Hot line to report these acts. (0800 003 056).

2. *Transnet SOC Limited is firmly committed to the ideas of free and competitive enterprise.*

- Suppliers are expected to comply with all applicable laws and regulations regarding fair competition and antitrust practices.
- Transnet does not engage with non-value adding agents or representatives solely for the purpose of increasing BBBEE spend (fronting).

3. *Transnet's relationship with suppliers requires us to clearly define requirements, to exchange information and share mutual benefits.*

- Generally, suppliers have their own business standards and regulations. Although Transnet cannot control the actions of our suppliers, we will not tolerate any illegal activities. These include, but are not limited to:
 - Misrepresentation of their product (origin of manufacture, specifications, intellectual property rights, etc);
 - Collusion;
 - Failure to disclose accurate information required during the sourcing activity (ownership, financial situation, BBBEE status, etc.);
 - Corrupt activities listed above; and
 - Harassment, intimidation or other aggressive actions towards Transnet employees.
- Suppliers must be evaluated and approved before any materials, components, products or services are purchased from them. Rigorous due diligence is conducted and the supplier is expected to participate in an honest and straight forward manner.
- Suppliers must record and report facts accurately, honestly and objectively. Financial records must be accurate in all material respects.



Conflicts of Interest

A conflict of interest arises when personal interests or activities influence (or appear to influence) the ability to act in the best interests of Transnet SOC Limited.

- Doing business with family members.
- Having a financial interest in another company in our industry

Where possible, contracts will be negotiated to include the above in the terms of such contracts. To the extent such terms are not included in contractual obligations and any of the above code is breached, then Transnet reserves its right to review doing business with these suppliers.

T2.2-20 Agreement in terms of Protection of Personal Information Act, 4 of 2013 ("POPIA")

1. PREAMBLE AND INTRODUCTION

- 1.1. The rights and obligation of the Parties in terms of the Protection of Personal Information Act, 4 of 2013 ("POPIA") are included as forming part of the terms and conditions of this contract.

2. PROTECTION OF PERSONAL INFORMATION

- 2.1. The following terms shall bear the same meaning as contemplated in Section 1 of the Protection of Person information act, No. of 2013 "(POPIA)":
consent; data subject; electronic communication; information officer; operator; person; personal information; processing; record; Regulator; responsible party; special information; as well as any terms derived from these terms.
- 2.2. The Operator will process all information by the Transnet in terms of the requirements contemplated in Section 4(1) of the POPIA:
Accountability; Processing limitation; Purpose specification; Further processing limitation; Information quality; Openness; Security safeguards and Data subject participation.
- 2.3. The Parties acknowledge and agree that, in relation to personal information of Transnet and the information of a third party that will be processed pursuant to this Agreement , the Operator is (insert name of Tenderer/Contractor.....) hereinafter Operator and the Data subject is "Transnet". Operator will process personal information only with the knowledge and authorisation of Transnet and will treat personal information and the information of a third party which comes to its knowledge as confidential and will not disclose it, unless so required by law or subject to the exceptions contained in the POPIA.
- 2.4. Transnet reserves all the rights afforded to it by the POPIA in the processing of any of its information as contained in this Agreement and the Operator is required to comply with all prescripts as detailed in the POPIA relating to all information concerning Transnet.
- 2.5. In terms of this Agreement, the Operator acknowledges that it will obtain and have access to personal information of Transnet and the information of a third party and agrees that it shall only process the information disclosed by Transnet in terms of this Agreement and only for the purposes as detailed in this Agreement and in accordance with any applicable law.
- 2.6. Should there be a need for the Operator to process the personal information and the information of a third party in a way that is not agreed to in this Agreement, the Operator must request consent

from Transnet to the processing of its personal information or and the information of a third party in a manner other than that it was collected for, which consent cannot be unreasonably withheld.

- 2.7. Furthermore, the Operator will not otherwise modify, amend or alter any personal information and the information of a third party submitted by Transnet or disclose or permit the disclosure of any personal information and the information of a third party to any third party without prior written consent from Transnet.
- 2.8. The Operator shall, at all times, ensure compliance with any applicable laws put in place and maintain sufficient measures, policies and systems to manage and secure against all forms of risks to any information that may be shared or accessed pursuant to the services offered to Transnet in terms of this Agreement (physically, through a computer or any other form of electronic communication).
- 2.9. The Operator shall notify Transnet in writing of any unauthorised access to personal information and the information of a third party , cybercrimes or suspected cybercrimes, in its knowledge and report such crimes or suspected crimes to the relevant authorities in accordance with applicable laws, after becoming aware of such crimes or suspected crime. The Operator must inform Transnet of the breach as soon as it has occurred to allow Transnet to take all necessary remedial steps to mitigate the extent of the loss or compromise of personal information and the information of a third party and to restore the integrity of the affected personal information as quickly as is possible.
- 2.10. Transnet may, in writing, request the Operator to confirm and/or make available any personal information and the information of a third party in its possession in relation to Transnet and if such personal information has been accessed by third parties and the identity thereof in terms of the POPIA.
- 2.11. Transnet may further request that the Operator correct, delete, destroy, withdraw consent or object to the processing of any personal information and the information of a third party relating to the Transnet or a third party in the Operator's possession in terms of the provision of the POPIA and utilizing Form 2 of the POPIA Regulations .
- 2.12. In signing this addendum that is in terms of the POPIA, the Operator hereby agrees that it has adequate measures in place to provide protection of the personal information and the information of a third party given to it by Transnet in line with the 8 conditions of the POPIA and that it will provide to Transnet satisfactory evidence of these measures whenever called upon to do so by Transnet.

The Operator is required to provide confirmation that all measures in terms of the POPIA are in place when processing personal information and the information of a third party received from Transnet:

1 Description of the *works*

1.1 Executive overview

The *works* that the *Contractor* is to perform *involve* The Scope of Work covers Transnet Freight Rail's requirements for the fencing at Laingsnek 11kV AC distribution substation and Laingsnek 3kV DC distribution substation under the control of the depot engineer, Heidelberg Depot. This specification should be read in conjunction with TFR's specifications as outlined in this document.

1.2 *Employer's objectives*

The *Employer's* objectives are to have the substation and the boundaries fenced to prevent unauthorised entry to the substation which in most cases have resulted in vandalism and theft and as a result the company have incurred huge cost in rectifying the damaged and to replace stolen assets.

2 Specification

Transnet Freight Rail Specifications and instruction

- BBF 3690: Electrical Safety Instructions ESI (2012).
- BBH 4465: Fencing and sterile zone
- BBB 5452: Transnet Freight Rail Requirements for the installation of Electrical equipment for 3kV DC Traction Substations.

2.1 PROPOSED SCOPE OF WORK FOR LAINGSNEK TRACTION AND DISTRIBUTION SUBSTATION.

The Scope of Work covers Transnet Freight Rail's requirements for the fencing at Laingsnek 11kV AC distribution substation and Laingsnek 3kV DC distribution substation under the control of the depot engineer, Heidelberg Depot. This specification should be read in conjunction with TFR's specifications as outlined in this document.

2.1.1 Service condition

Atmospheric conditions

Altitude 0 to 1800 m above sea level

Ambient temperature -5oC to +45oC

Relative humidity 10 % to 90%

Lightning Condition 12 ground flashes per square kilometre per annum

Pollution Heavily salt laden or polluted with smoke from industrial sources

2.1.2 Electrical conditions

Frequency The AC high voltage supply will normally be supplied by Eskom. The frequency will be 50 +/- 2.5 Hz

Supply voltage Under normal conditions the system supply voltage will be maintained at +/- 5% of the nominal voltage over a 24-hour period. Under crippled supply network conditions, the voltage can be expected to drop up to 15%.

Fault levels A three-phase short circuit on the supply will be limited to the following levels

Nominal Supply Voltage	Fault level
66 kV	20 kA
88 kV	25 kA
132 kV	40 kA

2.1.3 Security

It is the contractor's responsibility to safe guard and safely protect all equipment against possible theft or damage for the duration of the project.

2.1.4 Site rehabilitation

After completion of project the Contractor shall ensure that the site is clean and returned to its original state, any building damage shall be repaired.

All surplus and dismantled equipment and materials shall remain the property of Transnet Freight Rail and shall be transported to a Transnet Freight Rail designated site.

If there is oil spillage it shall be reported to Transnet Freight Rail and a detailed report on how the spillage occurred and the procedure of the removal of the oil from the soil shall be given to Transnet Freight Rail.

The oil spill shall be managed by a specialist contractor and on completion of the process to rehabilitate, the clearance certification will be submitted to Transnet Freight Rail for safekeeping.

2.1.5 Fencing

The fence supplied must installed in conjunction with BBH 4465.

The double mesh design of the fence shall be of aperture size small enough to exhibit both anti-cut and anti-climb characteristics i.e. aperture size should not be used/leveraged to aid in climbing the fence.

The contractor shall ensure the fence is corrosion resistant with Zinc-Aluminium alloy and PVC powder coating to prevent electrolysis from stray currents.

A double fence is required for sites specified by the Project Manager. Both the outer and inner fence posts shall have a height of 3400 mm. The aforementioned posts these shall be hot dipped galvanised with the galvanising thickness adhering to SANS121 and/or SANS3575, 4998 respectively - depending on the process of galvanising chosen. Any deviation of post dimensions or galvanising approaches will only be allowed subject to approval from the Project Manager.

None of the main posts may be joined by welding in order to comply with the specified height. The corner posts shall have a 12 mm diameter hole drilled in the centre of the section 300 mm above ground level for earthing purposes. The hole shall be drilled before galvanising. Any deviation from these dimensions will only be allowed subject to approval from the Project Manager.

2.1.6 The fence dimensions should be 3305mm wide x 3000mm height.

The fence shall have good see-through visibility - so that all equipment within the operational asset is clearly visible.

The welding at each intersection of the fence where required shall not increase the chance of penetrability i.e. fence strength must not be compromised and be as secure as at the continuous mesh panels.

The contractor shall ensure that the fence is surface finished after welding at all points where required.

The fence posts shall be fully integrated with anti-tamper fixings.

The corner posts shall have a 12 mm diameter hole drilled in the centre of the section 300 mm above ground level for earthing purposes. The hole shall be drilled before galvanising. Any deviation from these dimensions will only be allowed subject to approval from the Project Manager.

The contractor shall install all safety barriers in accordance with engineering instruction S 016 and BBB 5452 clause 41.0 and 42.0.

The contractor shall supply and install 4.6 m wide x 3.4 m height lockable (mechanical lock) gates in the perimeter fence to allow for:

- Entrance to operational asset building and/or yard.
- Entrance to the high voltage outdoor yard adjacent to the main transformer(s).

All metal parts of fences and gates shall be effectively earthed. These parts shall be Electrically connected to the earth mat with flexible conductors.

Padlocks and for locking the gates shall be provided by Transnet Freight Rail.

2.1.7 Pepper gas

The contractor shall supply and install pepper gas spray in the Distribution substation.

The pepper gas system shall be connected to a short message service system to allow for arming and disarming.

2.1.8 Inspection

Arrangements must be made timeously via the "Technician on site" for the Technical Officer or Project Manager to inspect the progress of the work.

Safe working on Transnet freight rail sites

The Contractor or his sub-Contractor shall be required to work on site in accordance with Transnet freight rail's safety specification E4E of April 1997 and the Occupational Health and Safety Act 85 of 1993.

The Contractor shall be required to work under direct supervision of Transnet freight rail's depot personnel on site and shall work only in the area which shall be demarcated by suitable barriers.

2.1.9 Standards and publications

Unless otherwise specified all the tests shall be conducted according to the latest editions of SANS, BS, IEC and Transnet Freight Rail's publications.

Transnet freight rail specifications / engineering instructions

Whenever "Transnet", "Spoornet" or "S.A. Transport Services" is used in the generic specifications, it should be read as "the Employer", and wherever "engineer" or similar terminology is used, it should be read as "the Engineering/Project Manager.

The Employer for this Contract is Transnet, SOC Ltd, trading as Transnet Freight Rail. The designs are based on the Transnet Freight Rail specifications.

The information and or requirements as stated in Transnet Freight Rail's specifications shall be considered as the minimum requirements for equipment to be offered. The Contractor may use the specifications as a requirement and offer material and equipment that comply with the latest technology. The Contractor shall provide details indicating how the equipment offered differs from what was specified.

Whenever "Technical Officer or Site Agent" is used in the specification it refers to Transnet Freight Rail's Contract Supervisor or his appointed representative.

2.1.12 Material

Transnet Freight Rail approved material shall be used.
The material or equipment shall be as per applicable drawings and standards, generic and specification.
Any alternative material or equipment to be used should be approved by Transnet Freight Rail before an order is placed, Transnet shall accept no liability for breach of this process.
Transnet Freight Rail shall inspect all equipment before dispatching the equipment to site.
Tendering procedure
Tenderers shall indicate clause-by-clause compliance with all specifications as well as the relevant equipment specifications.
The tenderers should fill in a separate document listing all the specifications clause numbers indicating the individual statement of compliance or non-compliance and clarifications.
Tenderers shall submit descriptive literature consisting of detailed technical specifications, general constructional details and principal dimensions, together with clear illustrations of the equipment offered.
Failure to comply with clauses 6.1, 6.2, 6.3 could preclude a tender from consideration.
The contractor is expected to commence with work within 30 days after the tender has been awarded.

2.1.13 General requirement

The Contractor must provide the suppliers and or manufacturers of his material and equipment with a copy of the equipment specification to ensure compliance.
The Contractor shall supply and install all material needed to complete the works, which shall be according to Transnet Freight Rail drawings, specifications and SABS.
The Contractor shall execute the Works in accordance with Transnet specification E7/1 and E4E.
The contractor shall commence work within the period specified in the schedule and the completion period shall be as indicate on the schedule.
The contractor shall submit copies of the tests report to the maintenance manager and the technical office of the project.
Work to be done under the cover of a work permit. All possible sources of supply are to be isolated and earthed.
The switching and earthing of the substation will be performed by an appointed Electrician from Transnet Freight rail with a Category A (Brown Licence) as per clause 302.2 BBF 3690.
The work permit shall be taken by the appointed Electrician according to Electrical safety instruction, section 8, clause 801.
The contractor will be liable for any damage caused by mismanagement or mishandling of the existing equipment on site.
Failure to comply with the specification will lead to the disqualification of the contractor.

2.1.14 Penalties

The following penalties will apply or part thereof for the delays. i.e. R2 500.00 per calendar day of the contract amount.

2.2 Review and Acceptance of Contractor Documentation

The *Contractor* submits documentation as the 'Works Information' requires to the *Project Manager* for review and acceptance.

In undertaking the 'Works' (including all incidental services required), the Supplier shall conform and adhere to the requirements of the 'Contractor Document Submittal Requirements' Standard included in Annexure 1 (Refer DOC-STD-0001).

2.3 TECHNICAL REQUIREMENTS

2.3.1 Commissioning of equipment

Commissioning will only take place after all defects have been rectified to the satisfaction of the Project Manager or Supervisor.

On completion of commissioning, the Contractor will hand the equipment over to the Project Manager or Supervisor in terms of the relevant instruction.

The commissioning of protection equipment by Transnet Freight Rail will in no way absolve the Contractor from any of his responsibilities during the guarantee period.

It is the Contractor's responsibility to satisfy him/herself that the commissioning of the protection equipment has been carried out in a satisfactory manner, and in no way compromises the proper operation of the equipment supplied in terms of the contract.

The Contractor shall be present during the testing and setting of the protection to rectify any faults found.

- 2.3.2** The *Contractor* grants the *Employer* a licence to use the copyright in all design data presented to the *Employer* in relation to the *works* for any purpose in connection with the construction, re-construction, refurbishment, repair, maintenance and extension of the *works* with such licence being capable of transfer to any third party without the consent of the *Contractor*.

3 Construction

3.1 Temporary works, Site services & construction constraints

3.1.1 The *Contractor* complies with the following requirements of the *Employer*:

The Contractor is specifically excluded from entering the Employer's operational area which is adjacent to the site and work area. The Contractor plans and organises his/her work in such a manner so as to cause least possible disruptions to the Employer's operations.

The Contractor ensures, adequate protection for his/her staff members and construction equipment. The Contractor will also be responsible for safe movement of motorists, pedestrian and general public in the vicinity of the works area.

The Contractor shall conduct all works within his/her work area and ensure that no personnel access the rail reserve situated above the work area.

3.1.2 People restrictions on Site; hours of work, conduct and records:

Site working hours will be the standard Transnet Freight Rail working day, which is from 07h30 to 16h00 on weekdays. No work will be permitted on weekends or public holidays unless a written request is submitted, a week prior to working, to the Project Manager for his acceptance.

3.1.3 The *Contractor* complies with the following hours of work for his people (including Subcontractors) employed on the Site:

07h30 to 16h00 on weekdays. No work on weekends and public holidays unless granted permission by the Project Manager.

3.1.4 The *Contractor* keeps daily records of his people engaged on the Site and Working Areas (including Subcontractors) with access to such daily records available for inspection by the *Project Manager* at all reasonable times.

3.1.5 The *Contractor* has no title to materials arising from excavations and demolition in the performance of the *works* with the exception of:

3.1.6 The *Contractor* performs the *works* and co-operates with:

The Employer to ensure that daily operations and activities are not affected whilst construction work activities continue.

A community liaison officer employed by the Employer, with all community related matters and concern raised. Sourcing local labour via the community liaison officer and Local Ward Councillors in performing the works, if required.

3.1.6 Publicity and progress photographs

Only in the interest of project progress submissions, photographs depicting work may be taken, upon request by the Project Manager.

3.1.8 The *Contractor* provides progress photographs at the discretion of the Project Manager in jpeg format at a location the Project Manager has communicated to the Contractor.

3.1.9 The *Contractor* does not advertise the contract or the project to any third party, nor communicate directly with the media (in any jurisdiction) whatsoever without the express written notification and consent of the *Project Manager*.

3.1.10 Contractor's Equipment

All earthmoving plant and equipment is to be stored at a designated area. Plant and equipment will only be removed from the designated store / lay down area. This plant and equipment should be returned to the store / lay down area before the end of the shift (i.e. no plant and equipment to be left on site). Registers of plant and equipment to be generated which will be monitored and maintained by the Contractor but must be available upon request from the Employer. Plant and equipment to be stored as per specifications.

3.1.11 The *Contractor* keeps daily records of his Equipment used on Site and the Working Areas (distinguishing between owned and hired Equipment) with access to such daily records available for inspection by the *Project Manager* at all reasonable times.

3.1.12 Site services and facilities:

The Employer will identify a lay down area, for the purpose of a site camp, stacking area and other areas if required. This shall be purely land, i.e. no supply of electricity, water, networking, ablutions, offices, store containers or bunded areas. The Contractor shall provide everything necessary for providing for the works.

3.1.13 The *Employer* provides the following facilities for the *Contractor*:
An un-serviced lay down area / site camp.

3.1.14 Wherever the *Employer* provides facilities (including, *inter alia*, temporary power, water, waste disposal, telecommunications etc.) for the *Contractor's* use within the Working Areas and the *Contractor* adapts such facilities for use, then the *Contractor* makes good and provides full reinstatement to the land (including all apparatus of the *Employer* and Others in, on or under the land) and surrounding areas to its original standard upon dismantling of such facilities and hand-back to the *Employer*.

3.1.15 Excavations and associated water control

The Contractor is to ensure that all excavations are adequately braced / shored, if necessary, as to prevent potential risk of harm / danger to his / her employees, motorist, pedestrian and the general public.

3.1.16 Where the *Contractor* encounters existing underground services, the *Contractor* undertakes the following:

The Contractor must cease all works immediately and notify the Employer's construction supervisor.

3.1.17 The *Contractor* complies with the following:

Noise levels are to be kept to a minimum standard, as the works to be undertaken is within a residential area. Residual rain water seepage, shall be managed by the Contractor, as to prevent flooding of excavations and subsequent damage to the existing concrete wall and roadway. OSH Act together with Transnet Policy and Procedures.

3.1.18 Giving notice of work to be covered up the Contractor shall notify the Construction Manager or Supervisor, in writing, 24 hours prior to covering up.

The Contractor notifies the Supervisor 24 hours prior upon witnessing field density tests to be conducted. A SANAS approved laboratory to conduct all testing on layer works and premix works.

3.1.19 The *Contractor* complies with the following constraints in the execution of the *works*:

The Contractor may have to interface their works with other contractors on site performing other aspects / disciplines of work required for the Employer.

The *Contractor* is permitted to carry out the following *works* after Completion:

- De-establish site
- Remove and re-instate all lay down areas and site camp
- Housekeeping
- Hand over all pertinent documents (material test reports, etc)

3.1.21 Materials facilities and samples for tests and inspections

The Contractor to provide all test results from a SANAS approved laboratory for all commercial sourced Concrete. Test samples to be carried out on site and sent to a SANAS approved laboratory to cross reference quality and conformance checks.

3.1.22 **Commissioning**

Upon completion, meeting required specifications and standards, the area of work shall be opened for general use.

3.1.11 The *Contractor* keeps daily records of his Equipment used on Site and the Working Areas (distinguishing between owned and hired Equipment) with access to such daily records available for inspection by the *Project Manager* at all reasonable times.

3.1.12 Site services and facilities:

3.1.13 The *Employer* provides the following facilities for the *Contractor*:

3.1.14 Wherever the *Employer* provides facilities (including, *inter alia*, temporary power, water, waste disposal, telecommunications etc.) for the *Contractor's* use within the Working Areas and the *Contractor* adapts such facilities for use, then the *Contractor* makes good and provides full reinstatement to the land (including all apparatus of the *Employer* and Others in, on or under the land) and surrounding areas to its original standard upon dismantling of such facilities and hand-back to the *Employer*.

3.1.15 Excavations and associated water control

3.1.18 Giving notice of work to be covered up the *Contractor* shall notify the Construction Manager or Supervisor, in writing, 24 hours prior to covering up.

3.1.20 The *Contractor* is permitted to carry out the following *works* after Completion:

3.1.21 Materials facilities and samples for tests and inspections

This shall be purely land, i.e. no supply of electricity, water, networking, ablutions, offices, store containers or bunded areas. The *Contractor* shall provide everything necessary for providing for the works.

An un-serviced lay down area / site camp.

The *Contractor* is to ensure that all excavations are adequately braced / shored, if necessary, as to prevent potential risk of harm / danger to his / her employees, motorist, pedestrian and the general public.

The *Contractor* must cease all works immediately and notify the *Employer's* construction supervisor. Noise levels are to be kept to a minimum standard, as the works to be undertaken is within a residential area. Residual rain water seepage, shall be managed by the *Contractor*, as to prevent flooding of excavations and subsequent damage to the existing concrete wall and roadway. OSH Act together with Transnet Policy and Procedures.

The *Contractor* notifies the Supervisor 24 hours prior upon witnessing field density tests to be conducted. A SANAS approved laboratory to conduct all testing on layer works and premix works.

The *Contractor* may have to interface their works with other contractors on site performing other aspects / disciplines of work required for the *Employer*.

- De-establish site
- Remove and re-instate all lay down areas and site camp
- Housekeeping
- Hand over all pertinent documents (material test reports, etc)

The *Contractor* to provide all test results from a SANAS approved laboratory for all commercial sourced Concrete. Test samples to be carried out on site and sent to a SANAS approved laboratory to cross reference quality and conformance checks.

3.1.22 Commissioning

Upon completion, meeting required specifications and standards, the area of work shall be opened for general use.

3.2 Completion, testing, commissioning and correction of Defects

3.2.1 The *work* to be done by the Completion Date

3.2.2 Commissioning will only take place after all defects have been rectified to the satisfaction of the Project Manager or Supervisor.

3.2.3 On completion of commissioning, the Contractor will hand the equipment over to the Project Manager or Supervisor in terms of the relevant instruction.

3.2.4 The commissioning of protection equipment by Transnet Freight Rail will in no way absolve the Contractor from any of his responsibilities during the guarantee period.

3.2.5 It is the Contractor's responsibility to satisfy him/herself that the commissioning of the protection equipment has been carried out in a satisfactory manner, and in no way compromises the proper operation of the equipment supplied in terms of the contract.

3.2.6 The Contractor shall be present during the testing and setting of the protection to rectify any faults found.

On or before the Completion Date the Contractor shall have done everything required to Provide the Works including the work listed below which is to be done before the Completion Date and in any case before the dates stated. The Project Manager cannot certify Completion until all the work listed below has been done and is also free of Defects, which would have, in his opinion, prevented the Employer from using the works and Others from doing their work.

3.2.1 The *Contractor* is permitted to carry out the following *works* after Completion:

Site rehabilitation

After completion of project the Contractor shall ensure that the site is clean and returned to its original state, any building damage shall be repaired.

All surplus and dismantled equipment and materials shall remain the property of Transnet Freight Rail and shall be transported to a Transnet Freight Rail designated site.

If there is oil spillage it shall be reported to Transnet Freight Rail and a detailed report on how the spillage occurred and the procedure of the removal of the oil from the soil shall be given to Transnet Freight Rail.

The oil spill shall be managed by a specialist contractor and on completion of the process to rehabilitate, the clearance certification will be submitted to Transnet Freight Rail for safekeeping.

3.2.2 Access given by the *Employer* for correction of Defects

3.2.3 The *Contractor* complies with the following constraints and procedures of the *Employer* where the *Project Manager* arranges access for the *Contractor* after Completion:

The *employer* will give site access to the *contractor* if a need arises for the correction of the defects which may arise or become noticeable after the *works* have been handed over to the employer by the *contractor*. The *Contractor* may not enter the site without making arrangements to access with the project manager.

3.2.4 Where the Association of South African Quantity Surveyors Model Preamble for Trades 1999 are used within the Works Information, the following interpretations and meanings shall apply:

3.2.5 In case of any conflict in interpretation, ambiguity or discrepancy between any Model Preamble for Trades 1999 (whether standard or written as a particular project specification) contained in the *Works Information* and the *conditions of contract*, the *conditions of contract* take precedence within the ECC Contract.

3.2.6 In case of any conflict in interpretation, ambiguity or discrepancy between any Model Preamble for Trades 1999 (whether standard or written as a particular project specification) contained in this paragraph 4.2 of C3.1 *Employer's Works Information* and specific statements contained elsewhere in C3.1 *Employer's Works Information*, the specific statements contained elsewhere shall prevail, without prejudice to the *Project Manager's* express duty to resolve any ambiguity or inconsistency in the *Works Information* under ECC Clause 17.1.

3.2.7 Within the Model Preambles for Trades 1999, the following amendments and interpretations shall apply:

Where the word or expression "Principal Agent" is used, read "*Project Manager*" or "*Supervisor*" as the context requires.

Where the word or expression "*Contractor*" is used, read "*Contractor*".

Where the word or expression "Engineer" is used, read "*Project Manager*" or "*Supervisor*" as the context requires.

Where the Model Preambles for Trades 1999 mention "rates" for measured work and any contractual statements relating to payment, all such statements shall be discounted, with the ECC *conditions of contract* taking precedence.

3.2.8 Within the Model Preambles for Trades 1999, A. GENERAL, the following amendments and interpretations shall apply:

Where the word or expression "bills of quantities" is used, this shall be discounted for the purposes of the *Works Information*. The ECC Contract Data - Part One states the main option to apply within the ECC Contract between the Parties.

3.2.9 Within the Model Preambles for Trades 1999, B. ALTERATIONS, B.2 MATERIALS FROM THE ALTERATIONS, CREDIT, ETC and C. EARTHWORKS, C1.4 Materials from demolitions shall not apply. C3.1 *Employer's Works Information* paragraph 3.1.6 states details of the *Contractor's* title (if any) to Materials arising from excavations and/or demolitions and how such Materials are either to be disposed of or re-used in the *works*.

3.2.10 Within the Model Preamble for Trades 1999 Q. PLUMBING AND DRAINAGE, Q.24 TESTS shall be deemed to be included within paragraph 3.2.1 of C3.1 *Employer's Works Information*.

3.2.11 Within the Model Preamble for Trades 1999 U. EXTERNAL WORKS, U.3.8 Process control tests shall be deemed to be included within paragraph 3.2.1 of C3.1 *Employer's Works Information*.

3.2.12 The principles, meanings and interpretation stated and established within paragraphs 6.2.1 to 6.2.8 with respect to the Model Preambles for Trades 1999 equally apply to the other Model Preambles for Trades 1999 references [state particulars of Model Preambles used] used within this paragraph 4.2 of C3.1 *Employer's Works Information*.

SECTION 2

4 Management and start up

4.1 Management meetings

Regular meetings of a general nature may be convened and chaired by the *Project Manager* as follows:

- Meetings of a specialist nature may be convened as specified elsewhere in this Works Information or if not so specified by persons and at times and locations to suit the Parties, the nature and the progress of the *works*. Records of these meetings are to be submitted to the *Project Manager* by the person convening the meeting within five days of the meeting.
- All meetings are to be recorded using minutes or a register prepared and circulated by the person who convened the meeting. Such minutes or register are not to be used for the purpose of confirming actions or instructions under the contract as these are to be done separately by the person identified in the *conditions of contract* to carry out such actions or instructions.

4.2 The Contractor's Invoices

4.2.1 When the *Project Manager* certifies payment (see ECC Clause 51.1) following an assessment date, the *Contractor* complies with the *Employer's* procedure for invoice submission.

4.2.2 The invoice must correspond to the *Project Manager's* assessment of the amount due to the *Contractor* as stated in the payment certificate.

4.2.6 The *Contractor* complies with the following PIRPMP

4.3 CONTRACTOR LIABILITY

- 4.3.1** The *Contractor* warrants that he will be liable to Transnet for any loss or damage caused by strikes, riots, lockouts or any labour disputes by and/or confined to the *Contractor's* employees, which loss will include any indirect or consequential damages;
- 4.3.2** The *Contractor* warrants that no negotiations or feedback meetings by the *Contractor's* employees shall take place on Transnet premises, whether owned or rented by Transnet.
- 4.3.3** The *Contractor* shall give notice to Transnet of any industrial action by the *Contractor's* employees immediately upon becoming aware of any actual or contemplated action that is or may be carried out on Transnet's premises, whether owned or rented, and shall notify Transnet of all matters associated with such action that may potentially affect Transnet.
- 4.3.4** The *Contractor* is responsible for educating its employees on relevant provisions of the Labour Relations Act which deal with industrial action processes, and the risks of non-compliance.
- 4.3.5** The *Contractor* is required to develop a Contingency Strike Handling Plan, which plan the *Contractor* is obliged to update on a three monthly basis. The *Contractor* must provide Transnet with this plan and all updates to the Plan. The *Contractor* is responsible to communicate with its employees on site details of the plan.

5 INDUSTRIAL ACTION BY CONTRACTOR EMPLOYEES

- 5.1 In the event of any industrial action by the Contractor's employees, the Contractor is required to provide competent contingency resources permitted in law to carry out any of the duties that are or could potentially be interrupted by industrial action in delivering the Service.
- 5.2 The Contractor warrants that it will compensate Transnet for any costs Transnet incurs in providing additional security to deal with any industrial action by the Contractor's employees.
- 5.3 In the event of any industrial action by the Contractor's employees, the Contractor is obliged:
- 5.3.1** To prepare and deliver to Transnet, within two (2) hours of the commencement of industrial action an Industrial Action Report. If the industrial action persists the Contractor is required to deliver the report at 8h30 each day.
- 5.3.2** The Industrial Action Report must provide at least the following information:
- a) Industrial incident report,
 - b) Attendance register,
 - c) Productivity / progress to schedule reports,
 - d) Operational contingency plan,
 - e) Site security report,
 - f) Industrial action intelligence gathered.
- 5.3.3** The final Industrial Action Report is to be delivered 24 hours after finalisation of the industrial action.
- 5.3.4** The management of the Contractor is required to hold a daily industrial action teleconference with personnel identified by Transnet to discuss the industrial action, settlement of the industrial action, security issues and the impact on delivery under the contract.



- 5.4 The resolution of any disputes or industrial action by the Contractor's employees is the sole responsibility of the Contractor.

- 5.5 Access to Transnet premises by the Contractor and its employees is only provided for purposes of the Contractor delivering its services to Transnet. Should the Contractor and its employees not, for any reason, be capable of delivering its services Transnet is entitled to restrict or deny access onto its premises and unless otherwise authorized; such person will deemed to be trespassing.

PART 4: SITE INFORMATION

Core clause 11.2(2) states

"Affected Property is property which

- Is affected by the work of the *Contractor* or used by the *Contractor* in Providing the Service
- is in the documents which the Contract Data states it is in."

In Contract Data, reference has been made to this Part 4 of the contract for the location of the Affected Property.

1. Description of the Affected Property and its surroundings

1.1. General description

Laingsnek substation is located just outside of Volksrust in a remote area surrounded by farms. The pictures below show the satellite view of where the substation is located. When coming from Joburg site, one will have to use R23 via Standerton going to Volksrust. When reaching Volksrust one will have to join N 11 and just about approximately 10 km after exiting Volksrust then join the service road that will pass by the farmers plots to reach the substation. The road is a service road (Dirt Road) and uneven which might be a little challenging when during rainy seasons.

1.2. Existing buildings, structures, and plant & machinery on the Affected Property

The substation is located next to the railway road where the trains are moving bi-directionally. The area is in the farmlands where there are livestock, ducks, dogs, and some horses. Since the climate is changing and the heat waves are sky rocketing, this is the season where the snakes, bees and Wasps will be visible in the area. The substation is in a standalone and quite place where one needs security when travelling or accessing the area as it is vulnerable to theft and vandalism. When it is raining the road to the substation is not easily accessible which usually have lots of mud where vehicles get stuck.

1.3. Subsoil information

Since the substation was broken into and cables were dug out, the yard is uneven which requires extra care when walking around the substation

1.4. Hidden services

The substation is in the farmlands there might be other wild animals that we may not be aware of as the area is very quiet and not a very busy. No riverbanks or water pipes have been spotted so far, but that does not rule out the fact that there might be underground waters. Eskom substation is still feeding and there are still dangers of 88 kV supply that come through to Transnet site. The current equipment though vandalised, it might still have "live" and dangerous. To access the substation authorization is required. No unauthorised person is allowed to enter the substation without authorization from Transnet Authorised personnel.

1.5. Other reports and publicly available information

Contractors should be on the lookout for nearby culverts near the substation to avoid any damages to their vehicles.

No hunting is allowed on site of any animals.

1.6 Landsend Substation Risk

The contractor and employees should take note of the following while on site:

- **Surrounding area**

- The area is situated in the remote area where there is minimal to no network services.
- Wild animals like monkeys, snakes, bees, and wasp etc.
- Even though there might not be wetlands, river, dams, lakes visible but caution should be taken for contaminated water that are not to be consumed by anyone working in the surrounding area.
- Contaminated soil due to spillages, anyone working in the area should ensure that they sanitise hands after handling any equipment.
- The ground is uneven which poses a risk of injuries to anyone who is walking without caution.
- Possibility of unrest from the farm around the Volksrust area when coming across unknown faces within their territory.
- Slippery roads when it's raining.
- The substation is situated next to the railway line where trains are moving bidirectional, all the personnel should avoid going across the railway line to avoid injuries and fatalities from being hit by the train as the train is silent when standing on the railway line.
- There are no trees or any form of shades nearby the substation, the area is extremely hot however the weather around Volksrust can change at any time, one needs to bring items that protect them from the sun and from the possibility of abrupt cold/wind or rainy weather.

- **Risk to personnel**

- Because of theft incident that took place in the substation, there might be cables lying around that needs to be treated as live until Transnet Freight Rail employee has verified that the equipment has no power.

-
- There is still High Voltage Source (88kV AC) feed from Eskom side that means anyone working in the substation should work or be in the designated areas as supervised by the authorised Transnet employee to avoid electrocution.
 - Uneven walk area, personnel should be aware of the area they are walking into.
 - The substation might have bees, everyone working or visiting the site should be aware of being stung.
 - **Community**
 - Because the community residing in the surrounding area, personnel and contractor working in the area should safely guard their personal belongings and valuable equipment.
 - The surrounding community has livestock, no one is allowed to help themselves on their livestock and access the field that is not within Transnet.
 - **Risk to business**
 - The substation should never be left unattended after the work has commenced to avoid further damages that may have additional costs to the company.
 - Transnet has experienced several fatalities in the past from staff working on site, because there will be dismantling of other equipment, correct procedures should be following when handling such equipment, to avoid any injuries that might occur.
 - Because the transformer will be taking out of the substation to the workshop, the contractor should make the necessary authorities aware to ensure that the public is not affected by Transformer movement.
 - There electrical feed is coming from adjacent substation, no one is allowed to operate any switch or equipment other than Authorised personnel.
 - No one is allowed to access, remove any Transnet equipment in the absentia of Transnet authorised personnel as this will be regarded as a criminal offence.
