DETAILED TECHNICAL SPECIFICATION

1. BACKGROUND

The SABC is South Africa's national public broadcaster. Its objectives are to provide a comprehensive range of distinctive programmes and services with the view to inform, educate, entertain, support and develop culture in all 11 official languages. Its principal activities comprise of television and radio broadcasting utilising 19 radio stations and 5 television channels. The SABC strive to maintain a leading role in the broadcasting industry and as such keep abreast with the constantly changing technology.

In ensuring that the SABC delivers on its mandate, a project is currently being implemented that will see new servers placed in its server room on the 3rd Floor Television. The SABC TV News server room is experiencing challenges with respect airflow. Therefore, the SABC seeks to appoint a suitably qualified mechanical contractor to manage, supply and install isolation panels and cold room curtains in the TV NEWS Server Room. The objective is to separate the hot and cold air from mixing which has compromised airflow efficiencies.

The 2 current air handling units' (both have main and backup) dispatches cold air from the ceiling and extracted from behind the racks, however, it is recommended that each area is isolated to prevent the mixing of hot and cold which is believed to contribute to the lack of adequate cold air. The SABC seeks the following services.

1.2 Scope of Works

- Contractor to measure and supply panels for rack insulation and mounting – Perspex or glass to be installed above the racks.
- Installation of panels above the racks to block hot and cold aisles
- Contractor to measure and supply cold room curtains in between the positioned racks curtains will be required from ceiling to floor. Refer to the drawings Annexure 1
- Installation of cold room curtains between the racks to isolate hot and cold areas
- Work must be completed within 2 weeks after PO is issued
- Supplier must have experience with server room insulation installation with dust prevention
- Supplier must be sensitive to not disrupt the functional racks
- Supplier to work in such a manner to avoid making noise due to studio on air operations and prevent dust particle falling into the rack equipment
- Supply of additional grills (to match existing) and ducting based on the sight/site briefing
- Quality of installation and labor must carry a minimum of 1 year warranty and must be included in the pricing

2. Location of Site

The assembly site is on the 3rd floor located at the **SABC Auckland Park TV campus**. The area will be accessible from entrance 5 on the Ground Floor.

3. CONTRACT PERIOD

4. RFQ Response Information

Vendors should state in writing in its quotation to the SABC that all furnished information, including price, will remain valid and applicable for 90 days from the date the vendor quotation is received by the SABC.

5. COSTING

The quotation must reflect a detailed cost breakdown, and any indirect costs associated with the rendering of required service as per the schedule in the **Scope of Service**.

6. PAYMENT

6.1. The SABC's standard payment terms are 60 days from date of Invoice.

7. EVALUATION CRITERIA

7.1. BBBEE and Price

- The RFQ responses will be evaluated on the **80/20**-point system.

7.2. Technical Evaluation

- The tender submission will be technically evaluated out of a maximum of **90**
- A threshold of **50** out of **90** has been set.
- All bidders achieving less than the set threshold will be declared non-responsive.

7.3. Objective Criteria

- SABC further reserve the right not to award this RFQ to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.

8. ADJUDICATION USING A POINT SYSTEM

- 9.1. The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder.
- 9.2. The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder
- 9.3. Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- 9.4. In the event that two or more bids have scored equal points, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- 9.5. However, when functionality is part of the evaluation process and two or more bids have scored equal points for B-BBEE, the successful bid must be the one scoring the highest score for functionality
- 9.6. Should two or more bids be equal in all respect, the award shall be decided by the drawing of lots.

9. POINTS AWARDED FOR PRICE

The **80/20** preference point system

A maximum of **80** points is allocated for price on the following basis:

- 9.1. Bidders who qualify as EME's in terms of the B-BBEE Act must submit a certificate issued by a verification Agency accredited by SANAS for the purpose of conducting verification and issuing EMEs with B-BBEE Status Level Certificates or DTI Affidavit.
- 9.2. Bidders other than EMEs must submit their original and valid B-BBEE status levels verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by a verification agency accredited by SANAS.
- 9.3. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate
- 9.4. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- 9.5. Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.
- 9.6. A tenderer will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intend sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended Sub-contractor is an EME that has the capacity and the ability to execute the sub-contract.
- 9.7. A tenderer awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capacity and the ability to execute the sub-contract.

10. COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

11. CONDITIONS TO BE OBSERVED WHEN TENDERING

- 11.1. The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- 11.2. No tender shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.
- 11.3. The Corporation reserves the right to:

Not evaluate and award submissions that do not comply strictly with his RFQ document.

Make a selection solely on the information received in the submissions and

- 11.3.1. Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
- 11.3.2. Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

10.
