Introduction to the Business Unit responsible for this RFQ

iThemba LABS (Laboratory for Accelerator-Based Sciences) is a multi-disciplinary research laboratory based at two sites in the Western Cape and Gauteng respectively, these provide facilities for:

- Basic and applied nuclear physics research using particle beams
- Research Radiation Biophysics
- The supply of accelerator-produced radioactive isotopes for nuclear medicine and research

All proposals will be evaluated by Supply Chain Management for administrative compliance, functionality, price and B-BBEE. Based on the results of the evaluation process and upon successful negotiations, iThemba LABS will approve the awarding of the contract to successful bidder.

The 80/20 preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status. If all bids received are more than R500k, the proposal will be cancelled and re-issued.

Service and testing required of cell line sample:

- a) We require *Mycoplasma* sp. test to determine if our cultured cells are contaminated with *Mycoplasma*.
- b) The South African National Accreditation System (SANAS)-accredited laboratory or service provider must perform a PCR to amplify the bacterial 16S rRNA fragment from DNA that they extract from our cultured mammalian cells.
- c) The service supplier must then purify and Sanger sequence any amplicon generated by the 16S rRNA PCR to identify any contaminating bacterial species.
- d) The SANAS-accredited laboratory or service provider must provide a certificate to confirm the *Mycoplasma* contamination status of our cultured cells or comment on any other identified contaminating bacterial species.
- e) The certificate must be supplied in German or English, date stamped, with a readable signature of the appropriate responsible authority, on an official letterhead or company document template, with a visible SANAS accreditation number or stamp.
- f) The SANAS-accredited laboratory or service provider must be based in Cape Town.
- g) The SANAS-accredited laboratory or service provider must either collect the sample at iThemba LABS (NRF iThemba LABS, Old Faure Road, Eerste River) or arrange for a courier to collect the samples. If the service provider is within 30 kms, hand delivery can be arranged.
