### UPGRADING OF MEDIUM AND LOW VOLTAGE NETWORKS IN CEDERBERG MUNICIPAL AREA - PHASE 3

Cederberg Municipality invites tenders for contract no: CED 06/2025-2026 for the Upgrading of Medium and Low Voltage Networks in Cederberg Municipal Area (Phase 3) in the 2025/26 financial year.

Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data (Clause C.2.1) are eligible to submit tenders. It is estimated that tenderers should have a CIDB contractor grading designation of **5EP** or higher.

All bids received shall be evaluated in terms of the Cederberg Municipality's Supply Chain Management Policy and Cederberg Municipality Preferential Procurement Policy of 2022/23. The 80/20 preference point systems will apply. Tenders will be evaluated in terms of price (80) and preference (BBBEE status 50% (10) and Locality 50% (10)).

The successful tenderer must also be registered on the Centralized Supplier Database (CSD). Tenderers can register on [www.csd.gov.za](http://www.csd.gov.za).
