TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER FOR IMPLEMENTATION, SUPPORT AND MAINTENANCE OF THE ICT WAN AND INTERNET INFRASTRUCTURE FOR THE SADPMR.

1. BACKGROUND

The SADPMR currently has offices in Kempton Park, Corner Bonaero Drive and Cote D Azur Avenue (Head Office) and Kimberley, 41 Schmidtsdrift Road.

The two offices are connected on a site-to-site VPN and an internet break-out is at the service provider's premises.

There are 120 users at the Head Office and 7 users in Kimberley.

Firewall, mail filtering, anti-spam and internet URL filtering(proxy) is at the service provider's premises.

3 site routers for our offices are leased, two at the Head Office and one at the Kimberley Office.

A DR environment has been provisioned at the service provider's premises where replication software replicates some of our systems on a scheduled basis (Warm DR environment)

2. OBJECTIVE

The main objective of this project is to ensure that all SADPMR offices are connected to a wide area network, internet and VPN services and ensure that all other internet related services are fully operational.

3. REQUIREMENTS

The SADPMR requires the following services:

- 3.1 Required hardware will be leased, configured and managed by the service provider
- 3.2 1 x Firewall which will cater as a gateway for all SADPMR internet related services
- 3.3 DNS, mail hygiene/antispam, email whitelisting of inbound/outbound email as well as URL filtering.
- 3.4 Head Office must have 2 routers for redundancy and Kimberley must have one (1) router
- 3.5 A site-to-site VPN for Head Office and Kimberley sites.
- 3.6 A private VPN gateway for users to connect remotely to the internal network with at least two-factor authentication
- 3.7 Annual renewal and management of the SADPMR domain name
- 3.8 Bulk email-sending to external stakeholders
- 3.9 Disaster recovery provisioning on the Azure platform
- 3.10 Disaster recovery and replication on Azure
- 3.11 Head Office bandwidth – 2 x 200Mbps both lines must be active and cater for redundancy, direct internet connection and must have separate routes
- 3.12 Kimberley bandwidth - 50 Mbps
- 3.13 Reporting and monitoring of all network endpoints.
- 3.14 The quotations and the duration of the contract will be for 3 (three) years.

4. DOCUMENT REQUIREMENTS

4.1 The supplier must provide five (5) different Reference letters that are contactable where such services were rendered. At least one (1) reference letter must be 8 years. Two (2) references must be Microsoft Azure related and two (2) reference letters must be relating to WAN/Network services.

4.2 The supplier must have at least 8 years' experience

4.3 The supplier must provide a project plan with timeframes in their response.

- 4.4 Qualifications and experience of team leader and team members with their CV's in executing such services must be attached.
- 4.5 The supplier must provide a detailed end-to-end WAN solution design diagram of the proposed infrastructure requirements.
- 4.6 The quotation must be valid for 60 days
- 4.7 The quotation currency must be in South African Rand at a fixed rate for the duration of the quotation.
- 4.8 The supplier must be a Microsoft Gold partner with Cloud proficiency, copy of the certificate must be submitted.
- 4.9 The supplier must provide a turn-key solution and must be fully implemented in line with industry best practice benchmarks
- 4.10 The suppliers must ensure that all technical staff assigned to this project be vetted
- 4.11 The successful bidder must agree to enter into a contract and a detailed SLA for the maintenance and support after the award

7. PROJECT OUTPUTS/OUTCOMES

An end to end turn-key fully functional WAN, VPN, Internet and DR solution.

The implemented solution should be fully documented as per SADPMR's requirements.

8. REPORTING

A written report prepared by the Project Manager must be submitted to the SADPMR weekly, reporting on the progress and highlighting the unforeseen challenges / risks.

9. COMPLETION DATE

It is expected that the appointed service provider will roll-out the required ICT infrastructure into the SADPMR within the period of two months after the signing of the contract.

A compulsory information / briefing session will be held at the SADPMR Head Office in Kempton Park – as per SBD 1 form.

11.1.2 TECHNICIAN REQUIREMENTS

- Technicians must have a minimum of 10 years' experience in installing, configuring, maintaining and troubleshooting the required services. Detailed CV's and qualifications of technicians executing such support services must be attached. The team leader/lead technician must be clearly highlighted.

11.1.3 PROJECT PLAN / METHODOLOGY

- Service providers are required to provide a clear project plan with final outputs and identified timeframes of the services to be rendered including maintenance plan for a period of thirty-six (36) months
- Project plan should include lead time schedule to install and integrate the hardware to the existing infrastructure.

11.1.4 INFRASTRUCTURE REQUIREMENTS
