REQUEST FOR PROPOSAL (RFP) FROM INDEPENDENT POWER PRODUCERS TO PROVIDE RENEWABLE ENERGY TO CEDERBERG MUNICIPALITY

Cederberg Municipality hereby request proposals from reputable and competent Independent Power Producers to provide 4 MVA AC renewable energy in Citrusdal, and/or 4.9 MVA AC in Clanwilliam, and/or 0.6 MVA AC in Graafwater, and/or 2 MVA AC in Lamberts Bay and/or 0.8 MVA AC in Elands Bay for a period of twenty (20) years under a Power Purchase Agreement.

Only tenderers who satisfy the eligibility criteria stated in the Tender Conditions and Tender Data (Clause C.2.1) are eligible to submit tenders.

All bids received shall be evaluated in terms of the Cederberg Municipality's Supply Chain Management Policy and Cederberg Municipality Preferential Procurement Policy of 2022/23. The 80/20 preference point systems will apply. Tenders will be evaluated in terms of price (80) and preference (BBBEE status 50% (10) and Locality 50% (10)).

The successful tenderer must also be registered on the Centralized Supplier Database (CSD). Tenderers can register on www.csd.gov.za.
