5. THE BIDDING SELECTION PROCESS

Stage 1 - Compliance to submission requirements

The NRF evaluates each bidder's written response to the specifications issued in accordance with published evaluation criteria set as in Section D.

Stage 2B – Due Diligence Interviews or Proof of Delivery/Concept against Specifications

Where circumstances justify it, the NRF conducts interviews with shortlisted bidders for them to present further information or provide further proof to the evaluation committee. In these cases, the National Research Foundation provides the areas of concern to the shortlisted bidders to address in their presentations with this document and, where necessary, may provide further areas of concern to the shortlisted bidders at this stage.

Stage 2C - Due Diligence Research

The National Research Foundation confirms the recommended bidder(s)'s reference letters with referees to confirm the recommendation(s).

Stage 3 - Price/Preference Evaluation

Basis of fair competition:

The NRF compares each bidder's pricing proposal on an equal and fair comparison basis equitable to all bidders, taking into account all aspects of the bid's pricing requirements including the application of fair pricing tests as set out below in the section "Insufficiency of Funds".

Ranking of the bidders pricing:

The NRF ranks the qualifying bids on price with lowest priced Bid receiving the maximum points (either 80 or 90) and the remainder ranked in relation to the lowest priced bid. The NRF adds the bidders' claimed preference points as verified to the submitted preference claim form (SBD 6.1) to provide the final ranking for the award decision.

Stage 4 – Checking Tax Compliance

Stage 4A – Taxpayers Resident in South Africa

The NRF notifies the recommended bidder in writing where their tax compliance check reflects that they are non-compliant and provides the recommended bidder seven (7) working days to submit written proof from SARS of their tax compliance status or proof that they have made an arrangement with SARS to meet their outstanding tax obligations. Failure to deliver such written evidence of compliance results in the rejection of that recommended bid.

Stage 4B - Non-Resident Foreign Bidders

When foreign bidders are submitting a bid, they complete all sections of the SBD1, especially the tax questionnaire. The NRF submitted the Foreign Bidder's completed SBD1 to the South African Revenue Service to obtain from the South African Revenue Service the Confirmation of Tax Obligations letter. Where South Africa Revenue Services does not issue the letter, Stage 4A applies in clearing the reason for not receiving the letter.

Stage 5 – Award and Contract Signing

The NRF nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

SCOPE OF WORK

INTRODUCTION TO THE NRF

The National Research Foundation Act, Act 23 of 1998, establishes the National Research Foundation ("NRF") as the juristic person that makes this bid invitation and will contract with the awarded bidder. The Public Finance Management Act classifies the organisation as a Schedule 3A Public Entity.

CONTEXT OF THIS PROCUREMENT

The SAEON seeks to appoint a service provider for a rental storage and technical workspace facility for the shallow marine and coastal research infrastructure (SMCRI) based in cape town for a period of two (2) years.

CONTRACT PERIOD

Two (2) Years- Renewable

DESCRIPTION OF GOODS/DETAILED SPECIFICATION

Requirements for a secured storage space:

- 1. **Location** must be in one of the following areas in Cape Town as defined on https://www.property24.com/:
 - Paarden Eiland; Montague Gardens; Marconi Beam Industria; Ndabeni; Epping Industrial; Southfield but only west of Princessvlei Road; Elfindale; Retreat but only west of the Southern Suburbs Railway Line; Ottery East; Capricorn; Westlake.
- 2. The facility should have easy access to one of the main highways such as the N1, N7, N2, M3 & M5 taking into consideration traffic volumes in the early morning and late afternoon.
- 3. Total Area:
 - Minimum of 90m², preferably approximately 120m²; not greater than 220 m²
 - Ground level storage: >90m² of the space must be on the ground floor

4. Vehicle Access:

- The facility needs to have sufficient external & internal space to accommodate the entry of a D/C bakkie towing an 8m Boat trailer (i.e. there must be sufficient space for manoeuvring the trailer into storage facility without being impeded by other tenants).
- Roller door access is required for the inside space: Roller door must be wide enough to accommodate the entry of Boat /Trailer with sufficient clearance (an ABSOLUTE minimum of 3.2m wide (but preferably 3.5m) and at least 3.5m high).
- Points above will be confirmed with an on-site inspection.
- 5. Internal space should have space for trailer and vehicle to be stored while hitched together. Acceptable alternative: i.) Vessel and vehicle can be parked separately inside as long as access is suitable.
- 6. Outside parking space for at least 1 additional vehicle. Options for visitors parking should also be available.
- 7. A separate pedestrian entrance should be available to the internal area.
- 8. The internal and external floor surface should be suitable for navigating with a trolley, pallet jack

and/or forklift.

- 9. Minor alterations to the space including the installation of shelving may be required by SAEON on occupation.
- 10. 2-year lease, renewable.
- 11. Preferred Occupation date: 1 March 2026.
- 12. The facility must have at least 1 toilet and wash basin.
- 13. The property should adhere to building codes and health and safety regulations.
- 14. Property owner's Insurance should be in place to cover normal risks to the building (e.g. damage due to water supply problems, etc).
- 15. Garbage removal services shall be available.
- 16. Adequate lighting and domestic electrical supply within the building and security lighting for the outside areas.
- 17. Security (24 hour, manned) required, preferably with CCTV.
 - It would be an advantage for the facility to be situated in an office or business park that already provides this level of security.
 - If a free-standing building, then perimeter electric security fencing, a fully functional Alarm System and CCTV is required to ensure the safety and security of the personnel entering the property and the working spaces, both outside & inside.
 - In all cases, perimeter Electric Fencing will be required.
 - 24-hour, 365-day access will be deemed an advantage.
 - Rental Suburb must be deemed safe for access by staff, especially over weekends and after-hours.
- 18. General internal requirements of the facility should include:
 - A kitchenette with a sink would be preferable.
 - A small office space would be advantageous.
 - An on-site cleaning service undertaken by the landlord would be advantageous.
 - A separate large sink (or trough) for cleaning of small equipment would be advantageous.
 - The facility should be fitted with an operational security and fire alarm system or there must be the option to install one.
 - SAEON would ideally require a facility for washing down equipment. An outside hosepipe connection and suitable drainage would be preferable to allow for cleaning of equipment.
- 19. Variable costs must be estimated (e.g. electricity) and the contract will take the variability into account.

SAEON will verify and confirm the above requirements with the shortlisted bidders prior the confirmation of the award. All bidders to confirm the possibility of access for a site inspection. The shortlisted bidders must be able to give access to SAEON in order to confirm the above and arrangements will be made for a site visit.
