Dube TradePort Corporation (DTPC) was created as a provincial public entity to develop Dube TradePort. Refer to www.dubetradeport.co.za for more information on DTPC.

DTPC requests proposals from suitably experienced and competent service provider for the supply and installation of RO membrane, associated accessories, supply of spare parts, clean-in-place process, and ad-hoc maintenance.

The services required shall include, but not limited to the following:

- Supply, delivery, fitting, testing and commissioning of RO membrane elements and associated accessories.
- Removal and replacement of activated carbon with activated carbon that will be supplied by DTPC.
- Conducting of Clean-In-Place (CIP) process on the RO membranes and management of the resultant chemical waste.
- Ad-hoc servicing and maintenance of the AWTW.
- Ad-hoc supply and installation of spare parts.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2022 using the 80/20 preference points system.

The 20 preference points will be allocated to the following groups, as per the split included in the bid document:

- I. 10 points will be allocated to Enterprises (or bidders) who are at least 51% or more Owned by Black People
- II. 10 points will be allocated to Enterprises (or bidders) who are located within KwaZulu-Natal.
