1. APPOINTMENT OF A SERVICE PROVIDER

Individuals and/ or organizations with over 6/10 years' experience and suitable qualifications are sourced to submit proposals for the facilitation of the review of the 5-year Corporate Strategic Session for 2024-2029 Period.

2. BACKGROUND

Johannesburg City Parks and Zoo (JCPZ) is a non-profit legal entity wholly owned by the City of Johannesburg Metropolitan Municipality (COJ). It was established as a Municipal Owned Entity

(MOE) mandated to develop, maintain, and conserve green open spaces and manage cemeteries in Johannesburg, as well as the Johannesburg Zoo. The Company has a portfolio of more than 20 000 ha of public green open spaces including parks, cemeteries, and nature reserves.

The JCPZ Corporate Strategic Plan 2018/19- 2023/24 has ended. Given the foregoing and line with good corporate governance practices and the legislative requirements of the MFMA, the Board of JCPZ is required to develop a corporate strategic plan for the organization, which will cover the five years 2024/25 – 2028/29. The participants in the session will consist of 30 officials inclusive of Board Members and the Executive Management.

3. SCOPE OF WORK

a) To conduct a macro environmental analysis covering but not limited to the following areas:

- a.1. Governance framework of JCPZ as defined by the CoJ.
- a.2. CoJ's GDS implications for JCPZ
- a.3. Policy and legislative framework guiding JCPZ.
- a.4. The impact of the changing economic conditions on the business of JCPZ
- a.5. Quantitative analysis of the demand for JCPZ's green services versus its supply capability

b) Input price and labour cost changes and their impact on operational output

- b.1. To do a sales and revenue trends analysis
- b.2. To conduct a PEST analysis
- b.3. To assess the pricing options available to JCPZ within the limits of the changing environment
- b.4. To assess the changing market dynamics of various market segments served by JCPZ and identify further target segments.
- b.5. To review the quality of services and products of JCPZ and identify areas of improvements and recommend those that JCPZ must be abandon.
- b.6. To analyse the structure of the green services industry and the alignment there of, within law, that can be explored by JCPZ.
- b.7. To analyse the financial health of JCPZ and identify potential dangers and strategies for dealing with these.
- b.8. To review the performance and potential for growth of the research, development and innovation functions
- b.9. To assess JCPZ's organizational culture and its impact on service delivery and growth of the company
- b.10. To assess the scope for synergy and service integration thus improving the cost structure
- b.11. To review the adequacy of the value chain activities and business model and recommend improvements.
- b.12. To review the current strategies, strategic fit, strategic positioning and advantage of JCPZ and then revise these.
- b.13. To re-define market niche and strategic positioning that will give the best value to the shareholder based on the Growth and Development Strategy (GDS)
- b.14. To conduct a SWOT analysis
- b.15. To generate strategic alternatives and assist JCZP in choosing the appropriate combination based on the best strategic fit.
- b.16. To develop a resourcing strategy (i.e. human, technological and financial) for JCPZ to succeed in fulfilling its strategic objectives.
- b.17. To identify key and potential risks that could hamper company from achieving its strategic objectives and mandate; and
- b.18. To develop appropriate response strategies and mitigation measures to manage identified risks.

4. METHODOLOGY AND IMPLEMENTATION (NB: In their proposal, bidders are requested to include a thorough project plan for carrying out the items listed below.)

It is expected that the appointed service provider will facilitate the a planning session with the Executive Management Team and the Board of the Directors of Johannesburg City Parks & Zoo where:

- A SWOT analysis, based on the below outputs, will be discussed, and adopted.
- Strategic alternatives derived from the above will be discussed and JCPZ will choose an appropriate combination based on the best strategic fit.
- Resourcing strategies (i.e. human, technological, and financial) for JCPZ to succeed in fulfilling its strategic objectives will be finalized and adopted
- Strategic risks register and mitigation measures to manage key risks facing the company in the implementation of the strategy and mandate are discussed and adopted.
- Successful bidder/s will be required to provide a detailed Corporate Strategic Plan 2023/24 - 2028/29 document.
- The service provider will also be required to provide a team-building session as part of the above session.

- c) The service provider will be provided with previous corporate planning documents that will form part of the aforementioned 2-day working sessions.
