**BACKGROUND**

The Occupational Health and Safety Act of South Africa stipulates that an employer must provide a healthy and safe work environment and use of personal protective equipment is allowed under certain conditions, for safety of employees. Section 43 of the Act makes provision for the Minister of Labour to make regulations pertaining to the types and manner of use of personal protective equipment. Several regulations which cover aspects of personal protective equipment have been published or incorporated into the Act.

The General Safety Regulations make provision for an employer to issue a wide range of personal protective equipment. However, the employer is still expected to undertake a risk assessment, and to take practical steps to remove or reduce exposures prior to issuing personal protective equipment. The Environmental Regulations for Workplaces make provision for use of personal protective equipment by workers who are exposed to environmental risk.
