TENDERS are hereby invited from competent and experienced contractors for the REFURBISHMENT OF LOOP STREET SWIMMING POOL IN PIKETBERG FOR BERGRIVIER MUNICIPALITY. **It is estimated that bidders should have a CIDB grading of 5CE or higher and must provide valid proof thereof.** CIDB registration shall be valid on the date of tender submission.

Bids, in sealed envelopes, clearly marked **“TENDER T 8.3.52-2026 MN193-2026 THE REFURBISHMENT OF LOOP STREET SWIMMING POOL IN PIKETBERG FOR BERGRIVIER MUNICIPALITY”**, must be placed in the tender box at the Municipal Offices, 13 Kerk Street, Piketberg no later than **12:00 on Monday, 5 October 2026** when the bids will be opened in public. **Bids addressed to any municipal official in his/her personal capacity will not be considered and will immediately be disqualified. A compulsory clarification meeting will be held on Tuesday, 15 September 2026 at 11h00 at Rhino Sports Field (c/o Main Road and Loop Street) in Piketberg. Gate closes @ 11:05.

Bids will be evaluated using the Council's Supply Chain Management Policy. It is therefore compulsory that the Preference Point Claim form for the Preferential Procurement Regulations is completed in full to make application for preference points of **80 points for price, 10 points for specific participation goals and 10 points for BBEE.** The **Bid price must be VAT inclusive.**

Bidders must be registered as a prospective supplier on National Treasury's Central Supplier Database (CSD). The Tax Clearance Certificate/ Tax Compliance Status (TCS) Pin/ Centralised Suppliers Database (CSD) Registration Number must be submitted together with the bid. Failure to submit a Tax Clearance Certificate/TCS Pin/CSD registration number may result in the invalidation of the bid. **Bidders must submit an originally certified B-BBEE Certificate / originally certified B-BBEE Sworn Affidavit. Failure to submit aforementioned will not render your bid non-responsive, but the bidder will score 0 points for B-BBEE.**

Only bids **completed in black ink** on the original Bid documentation will be accepted. Late, incomplete or Bids submitted by facsimile or email will not be accepted. Proof of submitting a Bid will not be accepted as proof of the Bid having been received. The Municipality is not obliged to accept the lowest or any Bid submitted to it. The Municipality reserves the right to accept any Bid in full or in part. If prices offered are cost effective Council reserves the right to procure more items to take financial advantage thereof.
