1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

14m x 24m Tunnel netting replace with 80% netting:

- 1.1 9 x 3m x 33m 80% Silver shade Netting stitched together.
- 1.2 74m Deep Zig zag aluminium locking strip with double wire on gable end and around and on the door side.

8m x 21m Tunnel

- 1.3 Replace the gable end's old netting with 40% Bl/Wh netting from the 14m tunnel roof. **Roof and gable covering:**
- 1.4 552m²Woven Polyethylene waterproof roof material on roof and gables.
- 1.5 Roof Black/White 40% netting on gable ends (from 14m tunnel roof)
- 28m Locking strip with Zig Zag wire on gables and 140m Pvc Plastigrip insert and lock
- 1.7 80% Silver roof netting stitched
- 1.8 300 x 98% shade net sandbags 350mm x 800mm
