1. PURPOSE

The purpose of this document is to call for proposals from experience service providers to assist the South African Local Government Association (SALGA) KZN to clean the interior of SALGA vacant buildings, cut the grass and trim the plants at number 60 Surprise Ridge Road Hillcrest, Durban.

2. KEY DELIVERABLES

The objective of this process is to appoint a suitable, experienced service provider within their respective regions as prescribed in the Request for Proposals (RFP). SALGA wishes to invite an experience service provider to clean vacant buildings, cut the grass and trim the plants at SALGA KZN facilities.

The proposal should be prepared simply and economically, providing a straightforward and concise description of the bid participant's ability to meet the requirements of the proposal request. Clear factual responses are required.

The content of the proposals shall determine the merit of each participant. However, should a participant or bidder wish to provide additional information apart from what is specified in this document, that information should be referred to, and provided for in a file of Annexure.

3. SCOPE OF WORK

The successful service provider is expected to provide the following services:

- Trimming of Plants and Tress
- Cutting of overgrown grass or Lawn

Deep Cleaning of all interior building's structures at Facility.

4. YEARS OF EXPERIENCE AND REFERENCES

The bidder should have at least minimum of three (3) years' experience with also minimum of three references for the similar type of services rendered

5. PRE-REQUIREMENTS

The bidder will be expected to have visited and examined our premises prior to submitting a response to these Terms of Reference during compulsory briefing session and to have satisfied themselves as to the efficiency and correctness of their response for the proper provision of any of the above services.

Compulsory sites visit to be Scheduled by SALGA and will be conducted a jointly site visit for all interested parties which will form a compulsory briefing session.

6. TOOLS OF TRADE

- The relevant tools of trade for deep cleaning / material, cutting of grass and trimming of plants / trees
- The service provider is also expected to transport garbage or waste produced during the execution of the work to the dumping site.

7. DURATION OF THE PROJECT

The project is once off. However, the appointed service provider will be expected to complete the project within the period of two weeks from the date of appointment.

8. UNIFORMS / PERSONAL PROTECTIVE CLOTHING (PPE)

The supplier must provide its employee/s with suitable PPE whilst working at our premises.

9. HEALTH AND SAFETY PLAN

Health and Safety Plan to be provided by service provider to protect its workers during the execution of the project. This include safe work practises since SALGA will not be responsible of any injuries and illness as a result of the service provider not protecting their workers. Health and Safety measures including safety data sheets to be included in the proposal.
