For us to price the products for 180 day option and then hold this for 12 months, is an effective 18 months price fix, that is impossible, the reasons being, the metal prices are linked to the London Metal Exchange, the republic Copper Price and the rand dollar exchange rate, these prices change on a monthly basis, added to this we have annual increases in labour, energy, monthly fuel price changes and all of this effects our consumers costs and our manufacturing costs. We ask humbly that these implications are considered as the state of our economy currently we have to price our products on a monthly basis. Further to the above, there will need to be a mechanism in place to calculate prices for year 2 through to year 5.
