Your attention is specifically drawn to the amendments, which are to be made to the tender document for the above in terms of this addendum, which is issued in terms of Clause 3.2 of the tender document.

Tenderers should take note of the following:

#### 1. CLARIFICATIONS

Requests for clarifications received since the issuing of Addendum number 14, and which don't require an addendum to the tender documentation, are addressed hereunder for the benefit of all tenderers.

#### Query 1:

Q: Can you please provide a clarification for the following:

Specified

External Glass:

Single Glazing - PG Smartglass - X1 Elite Low-E, as per SANS10400 and AAMSA. Glass thickness in accordance with TABLE 1 (PART N: GLAZING) of SANS10400.

From Glazing manufacturers:

According to AAAMSA regulations Low E single glaze glass is illegal in this region. Could you please let us know what your alternative will be?

A: To ensure AAMSA compliance, the following alternative must be used: PG SMARTGLASSX2, CLEAR, DOUBLE GLAZING AS PER SANS 10400 AND AAMSA. GLASS THICKNESS IN ACCORDANCE WITH TABLE 1 (PART N: GLAZING) OF SANS 10400 (OR EQUIVALENT).

## Query 2:

Q: Could you please clarify:

Items B2.60 to B2.64 Concrete Casing (reinforced) - please forward a typical detail, or reference to a current drawing, for the concrete encasement of the pipes.

A: The tendered rates for all concrete encasement to ensure compliance with Subclause 4.3.7.1 of SPE-CC-7003 (incl. project specific amendments). See below drawing references relevant for each item:

B2.60 - Refer to drawings 1001757-2000-DRG-CC-2541 and 2544.

- B2.61 Refer to drawing 1001757-2000-DRG-CC-2544.
- B2.62 Refer to drawings 1001757-2000-DRG-CC-2577.

Note, as per Subclause 4.3.7.1 of SPE-CC-7003: "Where no encasing width or height is given on the drawings, the encasement shall extend 300 mm above and below the pipe and 300 mm on both sides of the pipe."
