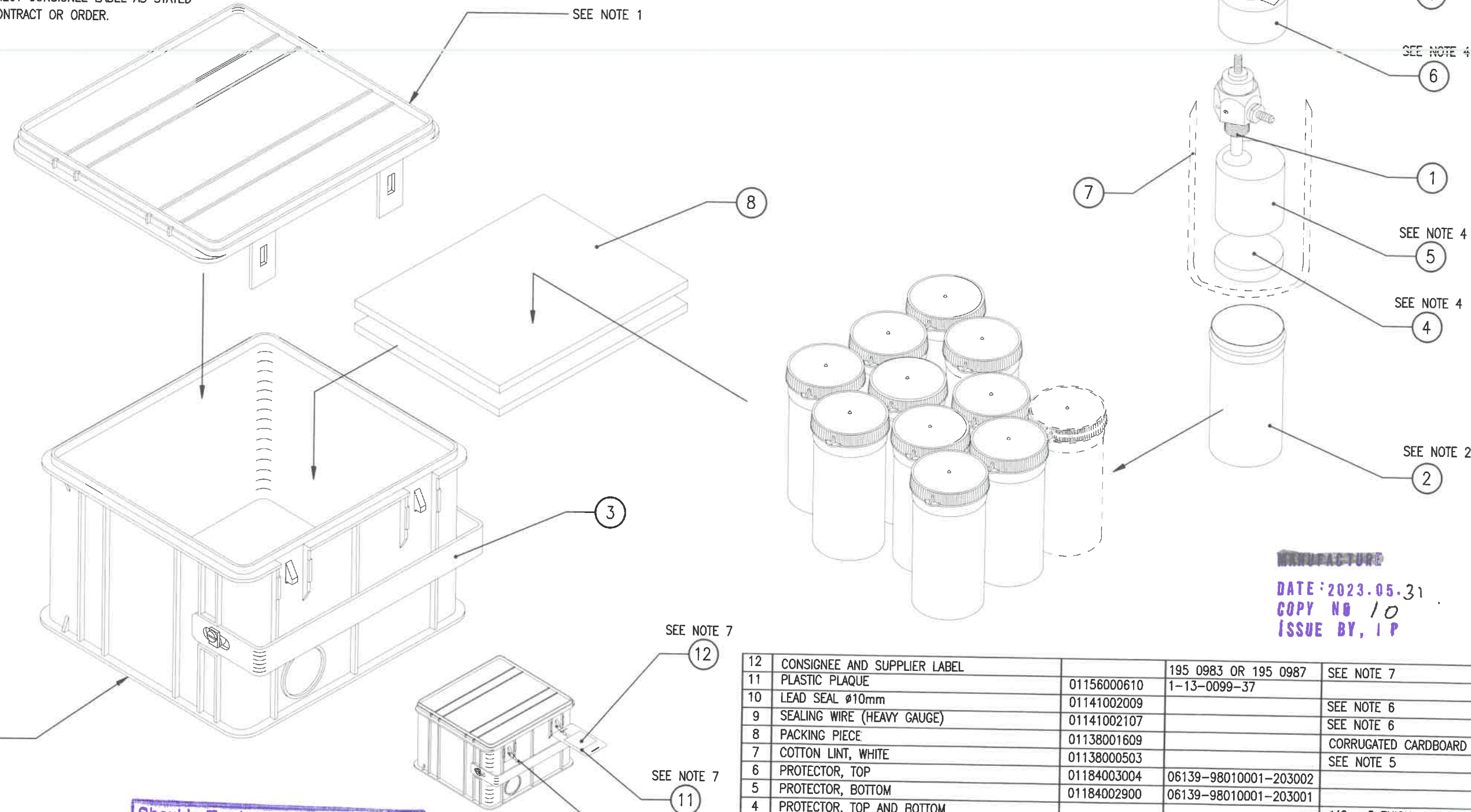


- NOTE:

 3. TO BE READ IN CONJUNCTION WITH SPEC. 06139-010001-111001.
 4. DOW ETHA FOAM 220. THE SUPPLIER SHALL ENSURE THAT NO BLOWING AGENT IS USED THAT WILL RELEASE ANY TRACES OF AMMONIA. THE COLOUR SHALL BE WHITE OR BLACK OR ANY SHADE OF GREY. A CERTIFICATE OF CONFORMANCE SHALL BE SUPPLIED WITH EACH DELIVERY. IF COC IS OMITTED BY THE SUPPLIER, A RANDOM SAMPLE SHALL BE ANALYSED BY THE PURCHASER. IF THE MATERIAL IS NOT AS SPECIFIED, THE ENTIRE BATCH SHALL BE REJECTED.
 5. A SUITABLE LENGTH (APPROXIMATELY 350mm MINIMUM) OF WHITE COTTON LINT, 6mm WIDE, SHALL BE INSERTED UNDERNEATH THE BOTTOM PROTECTOR. THE TWO ENDS SHALL THEN BE BROUGHT UP ON EACH SIDE AND FOLDED ON TOP OF THE TOP SPACER, TO LIE BENEATH THE LID.
 6. BOX TO BE SEALED WITH SEALING WIRE (HEAVY GAUGE) AND LEAD SEAL WITH EMBOSURE ON ONE SIDE. PLASTIC PLAQUE WITH LABELS TO BE ADDED TO ANY ONE OF THE FOUR SEALS.
 7. USE CORRECT CONSIGNEE LABEL AS STATED IN THE CONTRACT OR ORDER.
