In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for **APPOINTMENT OF PANEL OF MAXIMUM FOUR (04) CONTRACTORS TO ASSIST WITH MINOR ELECTRICAL WORKS FOR THE 2026/27, 2027/28 AND 2028/29 FINANCIAL YEARS ON AN AS AND WHEN REQUIRED BASIS**, in the Steve Tshwete municipal region. **Tenderers should have a CIDB contractor grading of 1 EP OR HIGHER.**

The tenders will be opened in public.

A non-compulsory clarification meeting will take place on 02/06/2026 starting at 14:00, at Electrical Workshop Boardroom, Municipal Stores (Magasyn), Cnr Walter Sisulu Street & Protea Road, Middelburg, 1050

Bidders will be evaluated on functionality whereby 70 points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where 80 points will be allocated in respect of price and 20 points in respect of Specific Goals. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
