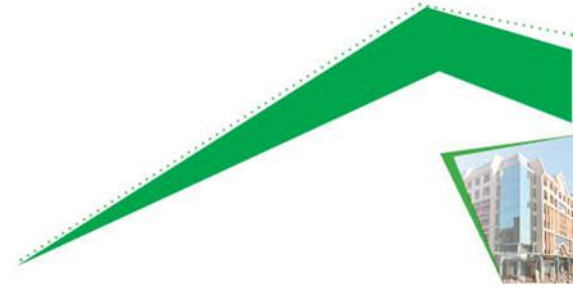

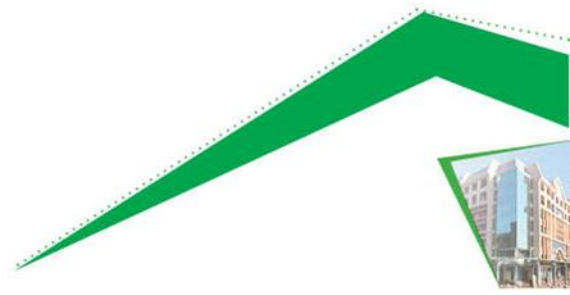

## PART T1: TENDER PROCEDURES

---

### T1.1 Tender Notice and Invitation to Tender

The Eastern Cape Department Public Works and Infrastructure invite Professional Service Providers for the **PROVISION OF PROFESSIONAL QUANTITY SURVEYING SERVICES FOR THE CONSTRUCTION OF XHORA MOUTH CLINIC**. Eastern Cape Department of Public Works and Infrastructure will enter into a contract with the successful tenderer. The contract will be based on the CIDB Professional services contract (Third edition) 2009.

Only tenderers who have suitable experience and suitably qualified personnel in providing similar services to those that are required are eligible to submit to tenders.

Tenderers are hereby informed that the department has or issuing the number of tenders targeting the same professional service providers. The department reserves the right not to award more than one bid in the case where one bidder has scored the highest points in other projects.

**NB: The preferred tenderer will be required to submit an approved insurer undertaking to provide the Professional Indemnity specific for the project within 21 days of appointment.**

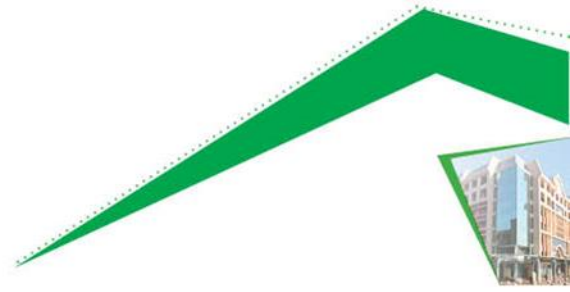
Bid documents are downloadable free of charge from the Department of Public Works and Infrastructure website ([www.ecdpw.gov.za/tenders](http://www.ecdpw.gov.za/tenders)) or from National Treasury's tender portal ([www.etender.gov.za/content/advertised-tenders](http://www.etender.gov.za/content/advertised-tenders)). **Bid documents will be available from 05 June 2026**. No bid documents will be available at department offices.

### **B. TENDER SUBMISSION:**

The closing time for receipt of tenders by the ECDPWI is 11:00am on the **09 July 2026**. Tender will be open in public.

Bids must be submitted in sealed envelopes clearly marked **SCMU5-26-/27-0018- PROVISION OF PROFESSIONAL QUANTITY SURVEYING SERVICES FOR THE CONSTRUCTION OF XHORA MOUTH CLINIC** and must be deposited in the bid box, **DEPARTMENT OF PUBLIC WORKS AND INFRASTRUCTURE, FRONT CORNER OF QHASANA BUILDING ON THE WAY TO CIDB OFFICES LABELLED "TENDERS", BISHO**.

It is the responsibility of the bidder/s to ensure that bid documents /proposals are submitted on or before closing time and at the correct location as the department will not take responsibility for wrong delivery. Bidders using courier services for delivery of their bid documents must ensure the delivery is at the correct place / location and time as the department will not be held responsible for wrong delivery. Bid documents must only be deposited in the bid box and not be handed over to any departmental official. The department will not accept responsibility if bids are handed to department officials and are not timeously deposited in the bid box.



Tenders may only be submitted on the tender documentation that is issued. Tenderers must be registered on the National Treasury Central Supplier Data Base and proof of registration must be submitted with the proposal (<https://secure.csd.gov.za>).

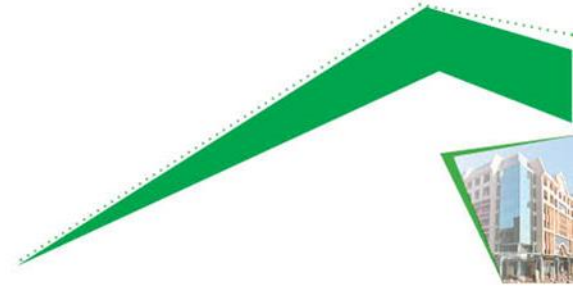

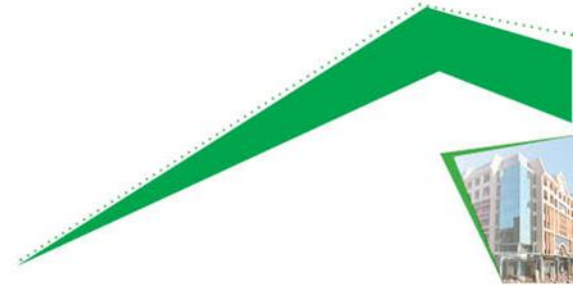
## T1.2 Tender Data

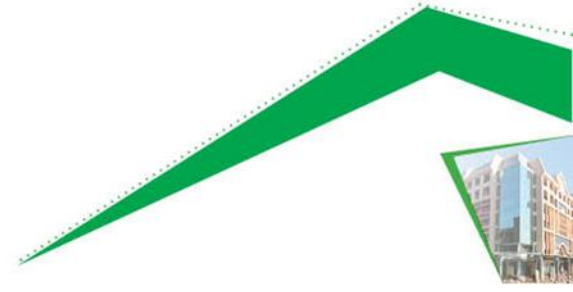

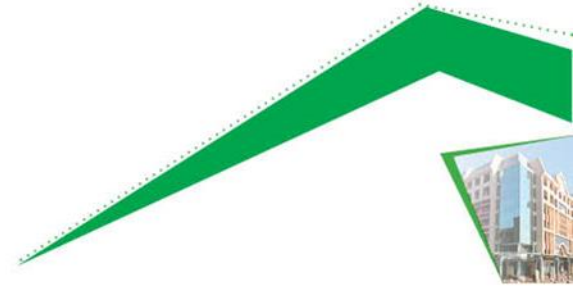

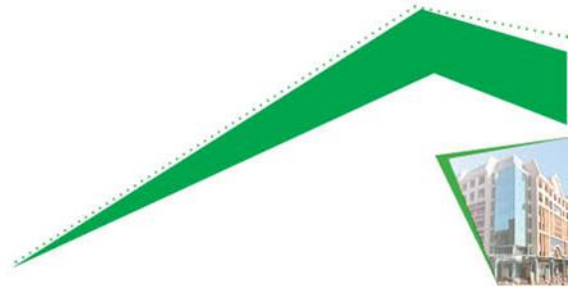

4.2	The Employer <b>will not</b> compensate the Tenderers for any costs incurred in the preparation and submission of a tender offer, including the cost of the tender being registered with SACQSP.
4.3	It is the responsibility of the tenderer to check the tender documents on receipt for completeness and notify the employer of any discrepancy or omission.
4.4	<b>Confidentiality and copyright of documents</b> Treat as confidential all matters arising in connection with the tender. Use and copy the documents issued by the employer only for the purpose of preparing and submitting a tender offer in response to the invitation.

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

## **PROTECTION OF PERSONAL INFORMATION: CONSENT (POPIA)**

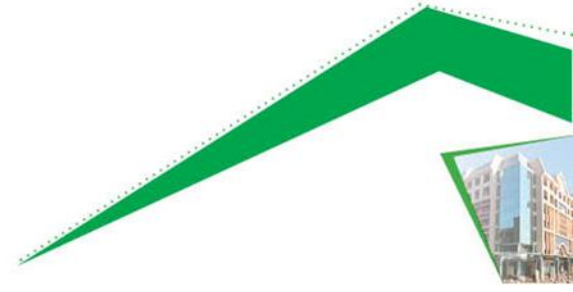

## C2.1 Pricing Instructions

Pricing Instructions refer to the criteria as set out below, read together with all Parts of the contract document, which it will be deemed in the contract that the Tenderer has taken into account when developing his prices.

1. The short descriptions given in the Pricing Schedule below are brief descriptions used to identify the activities for which prices are required. Detailed descriptions of the activities to be priced are provided in the Guideline Scope of Services with reference to the Quantity Surveying Profession Act, 2000 (Act No. 49 of 2000 – Govt Gazette commencement on 01 May 2024) for persons registered in terms of the South African Council for the Quantity Surveying profession (SACQSP), where applicable.
2. While it is entirely at the Tenderer's discretion as regards pricing the Activity Schedule below, the Guideline Scope of Services and Tariff of Fees for Persons Registered in terms of the 2013 Tariff of Professional Fees Schedule issued in terms of the Quantity Surveying Profession Act, 2000 (Act No. 49 of 2000 – Govt Gazette commencement 01 May 2024), respectively are useful documents that will give Tenderers some idea of industry norms against which they may compare their rates, sums, percentage fees and/or prices as applicable
3. The rates, sums, percentage fees (as applicable) used by a Tenderer to determine his offer shall not exceed the rates stipulated by the Guideline Scope of Services and Tariff of Fees for Persons Registered in terms of the SA Council for the Quantity surveying profession (SACQSP) and Department of Public Works: Rates for Reimbursable Expenses document, respectively.
4. For the purpose of the Activity Schedule, the following words shall have the meanings hereby assigned to them:
  - Unit: The unit of measurement for each item of work.
  - Quantity: The number of units of work for each item.
  - Rate: The agreed payment per unit of measurement.
  - Amount: The product of the quantity and the agreed rate for an item.
  - Sum: An agreed lump sum payment amount for an item, the extent of which is described in the Scope of Work, but the quantity of work which is not measured in any units.
  - Percentage Fee: The agreed fee for a service, the extent of which is described in the Scope of Work, expressed as a percentage of a construction contract value or part thereof.
5. A rate, sum, percentage fee and/or price as applicable, is to be entered against each item in the Activity Schedule. An item against which no price is entered will be considered to be covered by the other prices or rates in the Activity Schedule.

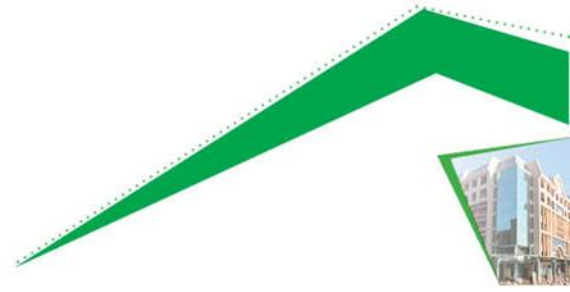

7. Where quantities are given in the Pricing Schedule, these are provisional and do not necessarily represent the actual amount of work to be done. The quantities of work accepted and certified for payment will be used for determining payments due and not the quantities given in the Activity Schedule. 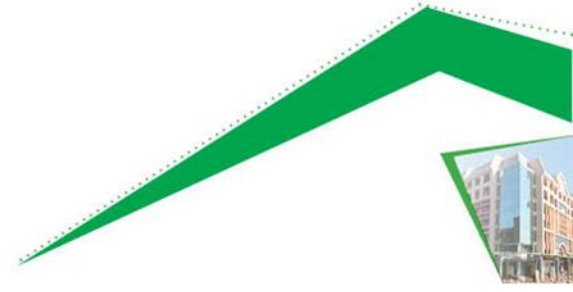

10. All other rates, sums, percentage fees or prices (as applicable) tendered in the Activity Schedule shall be final and binding and shall **not** be subject to any variation throughout the period of the contract.

While the Employer has every intention to complete the full scope of works, the Employer reserves the right to reduce or increase the scope of works according to the dictates of the budget, or to terminate this contract, without adjustment to the agreed rates, sums or fees and without payment



of any penalty or surcharge in this regard.
