### **1. Introduction**

Elias Motsoaledi Local Municipality requests the proposal from experienced service providers for supply and delivery of cleaning material, equipment and tools for a period of 36 months (3 years).

### **2. Executive summary**

Elias Motsoaledi Local Municipality in the 2021/2022 financial year budget has prioritized the supply project. Amongst other projects that were prioritized is the project that is serving on this Bid document classified as follows:

Appointment of Service Providers for the supply and Delivery of cleaning material, equipment and tools for a period of 36 months (3 years).

#### **2.1 Quality control and quality Assurance**
