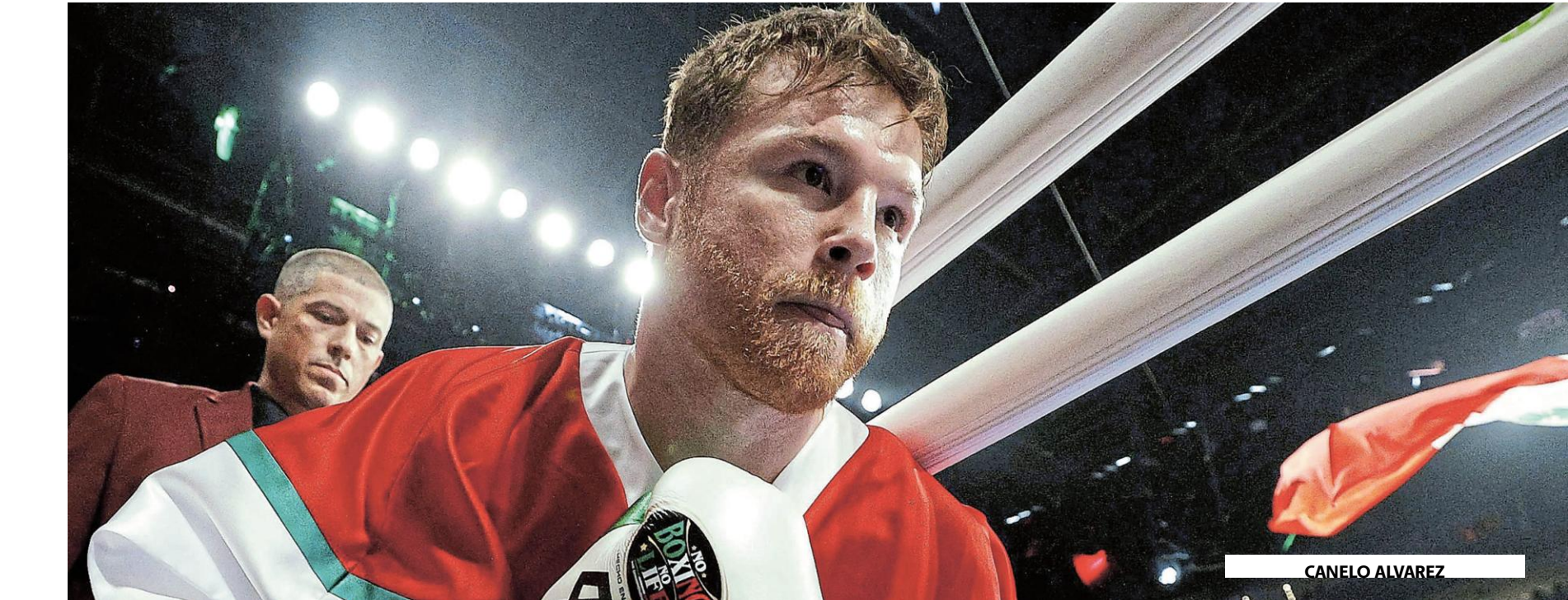

Alvarez retains undisputed super-middleweight title

Reigning champion credits patience for his eventual victory

Saul "Canelo" Alvarez retained his undisputed super-middleweight world title with a convincing unanimous decision over fellow Mexican Jaime Munguia on Saturday.

Alvarez handed Munguia the first defeat in 44 professional bouts, dropping the 27-year-old challenger in the fourth round and inexorably taking control to improve to 61-2-2 in his storied career.

The judges scored it 117-110, 116-111 and 115-112 for Alvarez, who retained his IBF, WBA, WBC and WBO belts.

Munguia, whose 34 knockouts included victories inside the distance in four of his previous five fights, came out on the attack against the vastly experienced Alvarez, pushing him back with his jab and rattling the champion in the third round with a right to the jaw.

But Alvarez responded in the fourth.

After Munguia connected with a pair of solid rights, Alvarez followed a left hook with a massive uppercut that sent Munguia to the canvas.

The fifth round opened to chants of "Canelo!" ringing in the T-Mobile Arena in Las Vegas, where support was evenly divided between the Mexican combatants in a fight coinciding with Mexico's Cinco de Mayo festivities.

An Alvarez jab popped Munguia's head back and, in the sixth, an Alvarez left hook had Munguia's knees buckling briefly.

In a fight billed as a possible changing of the guard, Munguia — who has honed his aggressive style under the tutelage of longtime Manny Pacquiao trainer Freddie Roach — continued to press.

But his vaunted power rarely bothered Alvarez, who repeatedly found a way past Munguia's guard to land the more damaging blows.

"You know, I take my time," Alvarez said of his measured start.

"I have a lot of experience. Jaime Munguia is a great fighter. He's strong, he's smart, but I take my time.

"I have 12 rounds to win the fight, and I did.

"I did really good and I feel proud about it," Alvarez, who hasn't posted a knockout since he stopped Caleb Plant in the 11th round in 2021, said.

Alvarez said after a few rounds he could see everything that was coming from Munguia.

"He's strong but he's a little slow," Alvarez said.

India's Siraj regains rhythm ahead of T20 World Cup

Royal Challengers Bengaluru's pace spearhead Mohammed Siraj produced a scintillating new-ball burst in Saturday's Indian Premier League (IPL) victory against Gujarat Titans to ease concerns over his form ahead of the T20 World Cup in June.

The 30-year-old, who has been picked in the 15-member India squad for the T20 showpiece, to be co-hosted by the US and West Indies, has struggled for form and rhythm in the ongoing IPL.

Siraj showed what he is capable of with the new ball against Gujarat as he dismissed opener Wriddhiman Saha and rival captain Shubman Gill in successive overs to help bundle out Gujarat for 147.

Bengaluru won by four wickets with 38 balls remaining and are now seventh in the points table following their fourth win in 11 matches.

"I haven't bowled with the new ball too much this season," Siraj, who was adjudged player of the match for his figures of 2-29, said.

"But this felt great because that new ball is my strength. Last year I did really well with the new ball. I got a lot of wickets. Today's performance brought back memories of last year."

Siraj is one of the three specialist fast bowlers in India's World Cup squad, and the right-arm pace was rested from the home game against Sunrisers last month.

"I had been playing red-ball cricket for a long time, and then suddenly a shift to white ball was not easy," he said.

"I was lacking in rhythm initially. But as I kept on practicing, I got my rhythm back."

Bengaluru assistant coach Adam Griffith was pleased with Siraj's return to form.

"Siraj is a rhythm bowler. He's the leader of our group," Griffith said.

"He's such an important part of what we're trying to do. So, having him up and going, swinging the ball again, bowling with good pace, and being aggressive is so important." — Reuters
