This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

### 1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

### 1.2 To be completed by the organ of state

The applicable preference point system for this tender is the **80/20** preference point system.

1.2.1 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

### 1.3 To be completed by the organ of state:

1.4 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.5 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

#### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

## 1. BACKGROUND

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

The Iziko South African Museum is equipped with an existing 500kVA standby diesel generator set which is currently under loaded. The Iziko Museums of South Africa (Iziko) invites suitably qualified electrical contractors to submit a quotation to connect additional existing Distribution Boards to the essential supply that will be supplied by the generator during power outages in the museum.

## 2. SCOPE OF WORK:

The scope of the electrical work includes the following:

- i. The Contractor is to complete to works that was started in Phase 1.
- ii. Phase 1 consisted of moving four Normal Section circuits over to the Standby Section on the Main LV Panel to optimize the existing standby generator load.
- iii. The Contractor must use circuit tracing equipment to trace the feeder cables and circuit breakers to/from the following DB's: **SDB EM5, SDB B3, SDB B8/EM6, SDB13/EM7, SDB17/EM8, DB19, SDB B16 and DB G-G/E** located in the museum public space area.
- iv. These DB's will be pointed out by Iziko Maintenance Personnel on site.
- v. When all feeders and circuit breakers are identified, the Contractor is to provide a hand sketch indicating all these cables and DB's
- vi. The contractor shall allow for 11 x data loggers for a period of 7 days (including a weekend) and forward the reports to Iziko/Engineer.
- vii. The data logging reports will confirm that the additional load of these DB's will not overload the existing generator.
- viii. Once this stage is completed, the Engineer will instruct the contractor with a specification and drawing/sketch to move all these Normal Supplies over to the Standby Supplies inside the existing Main LV DB (Substation).
- ix. The Contractor shall re-label the traced feeders on both sides with Brother labels and prepare red line "As-Built" drawings of the electrical reticulation.
- x. The Contractor shall supply and install new H07 single core cabling from the standby generator panel to these feeder circuit breakers in order to get it onto the generator output.
- xi. The Contractor shall re-paint (red) and label new generator supply circuit breakers as per SANS 10142 Regulations.
- xii. The Contractor shall inspect, test and issue Certificates of Compliance on the work carried out according to the latest certification standards of the Department of Labour.

### 3. **TECHNICAL REQUIREMENTS**

The contractor to be appointed for this work must comply with the following:

- 3.1 The company must be registered at the Electrical Contractors Association (ECA).
- 3.2 The company must have, in its employ, a competent person registered as a MV (11kV) switch operator with certificate.
- 3.3 The company must have, in its employ, a qualified electrician with a three-phase wireman's licence.
- 3.4 The company must be compliant with the OHS Act 85 of 1993.
- 3.5 The company must be registered with the Construction Industry Development Board (CIDB) and must have at least a minimum registration of Grade 1 EB - Electrical Engineering Works - Building

### 4. **COMPLIANCE DOCUMENTS**

### 5. **BILL OF QUANTITIES WITH PRICING (ANNEXURE B)**

Prices quoted must be valid for at least 90 (ninety) days from the closing of the RFQ. Furthermore, bidders must also submit a quotation in their company's letterhead indicating the total cost of the including VAT in rands.

#### **Pricing Instructions**

1. Payment will be made based on the deliverables for the goods received.
2. Payment will only be made on the basis of work completed satisfactorily, and invoices provided and approved by the project manager.
3. Offer to be valid for 90 days from the bid closing date.

**Please Note: a formal detailed quotation to be sent with proposal. The bill of quantities on Annexure B and a formal quotation must include all applicable costs and there can be no variation after award has been made.**

## **6. FORMAL CONTRACT**

- a) The proposal and appended documentation read together form the basis for an agreement to be negotiated and concluded in a formal contract between Iziko and the preferred Service Provider.
- b) A mere offer and acceptance shall not constitute a formal contract of any nature for any purpose between Iziko and the preferred Service Provider/s.

## **7. GENERAL PRINCIPLES**

- a) The lowest or only quotation received will not necessarily be accepted.
- b) Iziko and its Council reserves the right to accept or reject any quotation in response to the Request to Quote and to withdraw its decision to seek the provision of these services at any time.

## **8. DECLARATION**

The undersigned, who warrants that he / she is duly authorized to do so on behalf of the enterprise:

- i) confirms that neither the name of the enterprise or the name of any partner, manager, director or other person, who wholly or partly exercises, or may exercise, control over the enterprise appears on the Register of Tender Defaulters established in terms of the Prevention and Combating of Corrupt Activities Act of 2004;
- ii) confirms that no partner, member, director or other person, who wholly or partly exercises, or may exercise, control over the enterprise appears, has within the last five years been convicted of fraud or corruption;
