2.1 Despite the briefing session being non-compulsory, Transnet nevertheless encourages all Respondents to attend. Transnet will not be held responsible if any Respondent who did not attend the **non-compulsory** session subsequently feels disadvantaged as a result thereof.

3 PROPOSAL SUBMISSION

Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

a) The Transnet e-Tender Submission Portal can be accessed as follows:

4 RFP INSTRUCTIONS

- 4.1 Please sign documents [sign, stamp and date the bottom of each page] before uploading them on the system. The person or persons signing the submission must be legally authorised by the respondent to do so.
- 4.2 **All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**
- 4.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 4.4 Any additional conditions must be embodied in an accompanying letter. Subject only to clause 15 [Alterations made by the Respondent to Bid Prices] of the General Bid Conditions, paragraph 13 below (Legal Review) and Section 6 of the RFP, alterations, additions or deletions must not be made by the Respondent to the actual RFP documents.

5 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture [**JV**] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Transnet through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to Transnet.

6 COMMUNICATION

- 6.1 For specific queries relating to this RFP, an RFP Clarification Request Form should be submitted onto the system and to Mulweli Mukosi before **12:00 pm on 14 June 2022**, substantially in

the form set out in Section 8 hereto. In the interest of fairness and transparency, Transnet's response to such a query will be published on the e-tender portal and Transnet website.

- 6.3 Respondents are to note that changes to its submission will not be considered after the closing date.
- 6.4 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFP between the closing date and the date of the award of the business.
- 6.5 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

7 CONFIDENTIALITY

All information related to this RFP is to be treated with strict confidence. In this regard Respondents are required to certify that they have acquainted themselves with the Non-Disclosure Agreement. All information related to a subsequent contract, both during and after completion thereof, will be treated with strict confidence. Should the need however arise to divulge any information related to this RFP or the subsequent contract, written approval must be obtained from Transnet.

8 COMPLIANCE

The successful Respondent [hereinafter referred to as the **Supplier**] shall be in full and complete compliance with any and all applicable laws and regulations.

9 EMPLOYMENT EQUITY ACT

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

10 DISCLAIMERS

Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- 10.1 modify the RFP's Goods/Services and request Respondents to re-bid on any such changes.
- 10.2 reject any Proposal which does not conform to instructions and specifications which are detailed herein.
- 10.3 disqualify Proposals submitted after the stated submission deadline [closing date].
- 10.4 award a contract in connection with this Proposal at any time after the RFP's closing date.

- 10.5 award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP.
- 10.6 split the award of the contract between more than one Supplier/Service provider, should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations.
- 10.7 cancel the bid process.
- 10.8 validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so.
- 10.9 request audited financial statements or other documentation for the purposes of a due diligence exercise.
- 10.10 not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provided for it.
- 10.11 to cancel the contract and/request that National Treasury place the Respondent on its Database of Restricted Suppliers for a period not exceeding 10 years, on the basis that a contract was awarded on the strength of incorrect information furnished by the Respondent or on any other basis recognised in law.
- 10.12 to award the business to the next ranked bidder, provided that he/she is still prepared to provide the required Goods/Services at the quoted price, should the preferred bidder fail to sign or commence with the contract within a reasonable period after being requested to do so. Under such circumstances, the validity of the bids of the next ranked bidder(s) will be deemed to remain valid, irrespective of whether the next ranked bidder(s) were issued with a Letter of Regret. Bidders may therefore be requested to advise whether they would still be prepared to provide the required Goods/Services at their quoted price, even after they have been issued with a Letter of Regret.

Note that Transnet will not reimburse any Respondent for any preparatory costs or other work performed in connection with its Proposal, whether or not the Respondent is awarded a contract.

11 LEGAL REVIEW

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business. A material deviation from the Standard terms or conditions could result in disqualification.

12 SECURITY CLEARANCE

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the Goods/Services and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of **CONFIDENTIAL/ SECRET/TOP SECRET**. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

13 NATIONAL TREASURY'S CENTRAL SUPPLIER DATABASE

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Respondents must register on the CSD prior to submitting their bids. Business may not be awarded to a Respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD.

For this purpose, the attached SBD 1 form must be completed and submitted as a mandatory returnable document by the closing date and time of the bid.

14 TAX COMPLIANCE

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS**1 BACKGROUND**

Transnet Freight Rail (TFR) has a rail network of 30 400 track kilometers comprising 20 953 route kilometers of which 12 801 kilometers comprise the core network. The operating division maintains and sustains this rail network infrastructure over a long term for the safe and reliable passage of trains. The Railway infrastructure comprises of:

- Permanent Way (abbreviated to Perway)
- Electrical (Overhead Traction Equipment [OHE] & Substations)
- Train Authorization Systems
- Telecommunications.

The Perway Infrastructure comprises the embankments, cuttings, tunnels & bridges, and formation which support the sleepers, ballast and rails (track). A Rail Fastening System is a mechanism for fastening rails to sleepers. Currently, TFR is using two different types of Rail Fastening Systems which are the e-Clip type and the Fist type.

A Rail Fastening System consists of a different number of components, depending on the type of system:

The risk of non-supply of the Rail Fastening System would have direct impact on TFR's planned and unplanned maintenance projects. Lack of maintenance can potentially have negative consequences such as deterioration of the rail network, unsafe conditions, customer dissatisfaction and loss of business.

To ensure security of supply and to provide an opportunity for market transformation by testing and approving new products, TFR must have and maintain a suitable procurement mechanism for rail fastening systems.

To ensure a guaranteed and continuous supply of Rail Fastening Systems, Transnet has decided to frame an approved list for the supply of approved rail fastening systems. This will allow Transnet to continuously test new solutions or systems for inclusion in the approved list. Once the list is approved, TFR will be able to issue tenders to the members of the approved list to secure the supply of this strategic item over a long period of time subject to the Technology Plan.

2 EXECUTIVE OVERVIEW

The selected Supplier(s) to be framed into the approved list for the supply of approved rail fastening systems must share in the mission and business objectives of Transnet. These mutual goals will be met by meeting contractual requirements and new challenges in an environment of teamwork, joint participation, flexibility, innovation and open communications. In this spirit of partnership, Transnet and its Supplier(s) will study the current ways they do business to enhance current practices and support processes and systems. Such a partnership will allow Transnet to reach higher levels of quality, service and profitability.

Specifically, Transnet seeks to benefit from this partnership in the following ways:

- 2.1 Transnet must receive reduced cost of acquisition and improved service benefits resulting from the Supplier's economies of scale and streamlined service processes.
- 2.2 Transnet must achieve appropriate availability that meets user needs while reducing costs for both Transnet and the chosen Supplier/Service provider(s).
- 2.3 Transnet must receive proactive improvements from the Suppliers with respect to supply of Goods and related processes.
- 2.4 Transnet's overall competitive advantage must be strengthened by the chosen Supplier's leading edge technology and service delivery systems.
- 2.5 Transnet end users must be able to rely on the chosen Supplier's personnel for service enquiries, recommendations and substitutions.
- 2.6 Transnet must reduce costs by streamlining its acquisition of Goods, including managed service processes on a Group basis.

3 SCOPE OF REQUIREMENTS

3.1 Business Requirements

This procurement event is for the framing of an approved list for the supply of rail fastening systems. An approved list is essentially a "standing authority to confine" and is chosen as the best methodology

to procure because rail fastening systems are required according to unique Transnet specifications, on a continual ("as and when required") basis and from a limited number of suppliers.

The selection of a fastening system must be made with utmost care for, railroad safety can't be compromised. Hence it was decided that; unless the Fastening Systems have been tested and approved by Transnet, systems that are not approved must be subjected to a Transnet-specific product approval process.

Understanding the aforementioned conditions, and also taking into consideration the fact that Unapproved Fastenings may result in derailments, unsafe conditions, customer dissatisfaction and loss of business, this approved list is issued to achieve three objectives:

- Instantly frame the list with an inclusion of previously approved rail fastening systems.
- Conditionally approved fastening systems will be provisionally added into the approved list to allow for the procurement of samples for the in-service testing (to only be used once unconditional approval has been granted); and
- Test and approve new fastening systems that meets TFR's specification, to be included in the approved list once unconditional approval has been granted.

Although the approved list shall remain valid for an indefinite period, it will be advertised every 12 months in order to afford new suppliers an opportunity to be included. The lists will also be open to new entrants any time without necessarily waiting for the 12 months interval to be included.

Notwithstanding the existence of this approved list, Transnet reserves the rights to use an Open Bid or quotation process for Goods appearing on it should it be deemed beneficial to Transnet or in instances when the suppliers in the approved list fail to provide the products/services required by Transnet.

3.2 Deliverables:

The key deliverables of this project will encompass:

a) Framing the list for the supply of Approved rail fastening systems.

The procurement event (Framing an Approved list) is being issued with a particular aim of opening up the market for new market entrants. Bidders need to demonstrate that their products and/or processes do comply with Transnet's Technical specifications - BBF9273 V5 (**Annexure B**) in order to qualify for a product testing opportunity.

b) Inclusion of Specialised Pads into the list

Specialized pads (Some resilient pads and pads for baseplates and chairs) are considered a specialist "niche" area manufactured by specialist suppliers and not necessary fastening suppliers

it was decided to include these pads and evaluate them in a system using the fastening specification.

c) Testing and approval of unapproved rail fastening systems

Once a bid has successfully complied with the tender evaluations processes and have been selected for the testing process, bids will commence with the testing and approval process conducted by Track Technology Management (TTM).

The roadmap to approval includes the following four distinct phases and process owners as indicated:

Phase 1: Technical due diligence (High level – TTM process)

- Definition and agreement on the system offered for testing.
- Supply of the necessary technical documentation for technical approval prior to the start of the testing
- A high-level technical evaluation of the proposed system based on a presentation of the system by the bidder on the system offered and all its components.

Phase 2: Laboratory testing (TTM process)

- Agreement by the preferred bidder on the deadlines for submission of required documents and samples.
- Agreement on the tests that will be performed, as per specification.
- Transnet requesting samples from the supplier for testing
- Training by bidder on correct installation and supply of installation tools and jigs
- Laboratory testing of the various components
- Conditional approval if the above phases are completed which would allow for the installation of a test section

Phase 3: In-service testing

Phase 3A: Installation of in-service test section (Rail network process)

- Sourcing of samples and tools for in-service testing
- Evaluation of samples and testing of concrete sleeper assembly and selection of the test site (TTM)
- Installation of test section (TTM will oversee correct installation while bidder will supply training on correct installation)

Phase 3B In-service testing (TTM process)

- Confirm that samples were correctly installed
- In-service testing and evaluation of the system

Phase 4 Compliance of system (TTM process)

- Report indicating compliance or non-compliance with the specification and providing an indication of the shortcomings.
- Successful completion of phase 4 will lead to unconditional approval.

The In-Track test is administered over a 12 months period to observe the performance of the product under various climatic conditions throughout the four seasons of a year.

Transnet will furnish the suppliers with an updated roadmap to approval as each phase is completed. During the awarding of the test opportunity to respective suppliers, timelines will be agreed upon to ensure that suppliers provide the appropriate documentation/samples for test and evaluation. The table below depicts the estimated timelines:

Suppliers not meeting the deadlines may be disqualified from the product testing process and will thus not be included in the approved list.

3.3 Approved List Basic Terms and Conditions:

Through this procurement event, TFR intends to frame an approved List. This approved list will not have direct contractual obligations. Contracts with individual suppliers will only be concluded as and when a specific scope of work is required.

Through this approved list, TFR shall:

- Instantly frame the list with an inclusion of previously approved rail fastening systems.
- Provisionally add conditionally approved products into the approved list to allow for the procurement of samples for the in-service testing (to only be used once unconditional approval has been granted); and
- Once the approved list is framed, TFR will issue RFX to all members of the approved list with the intention to:
 - Award a contract to unconditionally approved supplier/s for the periodic supply of approved rail fastening systems
 - Procure limited number of samples for in-service testing from conditionally approved suppliers.
- Test and approve new fastening systems that meets TFR's specification, to be included in the approved list once unconditional approval has been granted.

TFR will issue various RFX to the unconditionally approved suppliers to secure a continuous supply of rail fastening components

Through this approved list, Transnet will be able to award "as and when" contracts for a period of up to five years

The approved lists will remain valid for as long as there is a need for rail fastening systems. An "as and when" contract may be entered into with the various bidders for a specific period. The approved list will be advertised every 12 months in order to afford new suppliers an opportunity to be included. The lists will also be open to new entrants any time without necessarily waiting for the 12 months interval to be included.

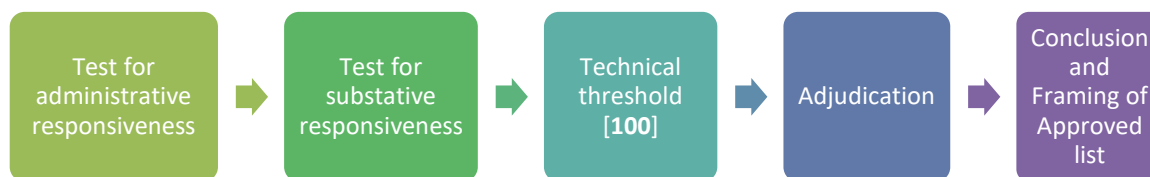

6.4 STEP FOUR: Adjudication Process

Technically compliant Bids will be recommended for the framing of an approved list in the following manner:

- Unconditionally approved products will be instantly framed onto the approved list
- Conditionally approved products will be provisionally included in the approved list
- Unapproved products will enter the test and approval of unapproved rail fastening systems phase and if approved conditionally or unconditional follow the process as indicated in the two bullets above.

6.5 STEP FIVE: Conclusion

- Immediately after approval to frame the list has been received, the successful or preferred bidder(s) will be informed of the acceptance of his/their Bid by way of a formal Letter. Thereafter the system will enter the test and approval of unapproved rail fastening systems phase (if applicable) with the successful Respondent(s). Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).
