Tenders are hereby invited from suppliers for:

Formal tenders sealed and individually clearly marked “with the tender number and description of choice as detailed above” must be placed in the Municipal tender box, **26 Church Street, OUDTSHOORN** no later than **12h00** on **THURSDAY, 07 DECEMBER 2023** and will be opened in public immediately thereafter at the **Supply Chain Management Office, CORNER OF 26 Church Street and St Georges Street, OUDTSHOORN (Main entrance at St Georges Str)** or any alternative place in Oudtshoorn Municipal Offices.

A set of fully completed tender documents must be submitted on the original documents and remain valid for a maximum of **120 days** after the closing date of the tender. A set of tender documents can be obtained at a non-refundable cost of **R361.00 including VAT** for hard copies directly printed by the Municipality and **free of charge when provided on pdf via e-mail**. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation to tender and / or re-advertise or to reject any formal tender or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

The above formal tenders will be evaluated and adjudicated in terms of the **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2022), and Oudtshoorn Municipality's Supply Chain Management Policy.
