Tenders may only be submitted on the prescribed tender documents and must include a valid Tax Compliance Status **PIN** as issued by **SARS**.

Late bids and bids received by E-Mail or Facsimile will not be considered. Bids will be evaluated and adjudicated in accordance with the Swellendam Municipality's preferential procurement policy and its Supply Chain Management Policy which may include minimum eligibility and functionality criteria. The **80/20**-point system will be applicable. Failure to comply to minimum requirements will result in a non-responsive tender. The Council does not bind itself to accept the lowest or any bid and reserves the right to accept a bid in full or a part thereof.
