	Kraal sides made of 2mm thickness steel, Every kraal side must come 16 mm steel pin , kraal side and gates should be coated with grey primer and with olive green enamel paint	
2.	Neck Clamp (Brahman)	4
	The Brahman neck clam should have a solid study base make from 4 mm plate, the ratchets should be 20 mm thick, the neck clamp should be reversible and be able to be fitted in any crush with the brackets provided, the doors should be adjusted to fit different sizes of cattle
