Part T1.1 - Tender Notice and Invitation to Tender ➤ It was emphasised that the Closing date is 05 November 2025 at 10:00, please refer to page 3 of 5 under Item 2 (tender submission) under T1.1 for instruction to upload the tender document. ➤ Bidders are required to ensure that electronic bid submissions are done at least a day before the closing date to prevent issues which they may encounter due to their internet as Transnet will not be held liable for any challenges experienced by bidders as a result of the technical challenges.
