INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). Furthermore, SANParks oversees the management of the parks and provide strategic guidance and support from its Head Office in Pretoria.

BUSINESS UNIT RESPONSIBLE FOR THE BID

This BID will be led by the Addo Elephant National Park Management team. Addo Elephant National Park was proclaimed in 1931 managed by South African National Parks. The Park is located near Gqeberha in the Eastern Cape Province in the Republic of South Africa.

CONTEXT OF THIS PROCUREMENT

CONTRACT PERIOD

The contract will be for a period of **36 months (3) years**.

SPECIFICATIONS/SCOPE OF WORK

South African National Park seeks to appoint a service provider for the maintenance of all water pumps, boreholes, and pool pumps at AENP for a period of three (3) years.

The focus areas of the service are:

The scope of work entails the repair of a variety of pumps utilized by the Addo Elephant National Park. Repairs and maintenance work on existing and any other pumps that Addo Elephant National Park may purchase during the contract period. Repair and maintenance services will be required when the need arises.

The contractor is responsible to determine the cause of fault based on the symptom, and to effect necessary pump repairs to maintain the original efficiency to acceptable standards. This may include complete overhaul and assembly. For every pump that has been repaired a detailed test report, certificate and pump performance curve shall be submitted to the client.

The service provider will be required to maintain and keep proper record of pumps serviced, repaired or maintained. This will include the servicing of the generator engines, alternator for borehole pumps and solar systems.

The service provider is expected to complete any repairs or maintenance, work within 24 hours after a formal request from SANParks – Addo Elephant National Park. Service provider is expected to provide a replacement pump or loan pumps when pumps are being serviced.

The turnaround time for repair and maintenance works is 24 hours from the formal request, service provider is expected to specify the turnaround time on the quotation.

The service provider must provide quotation for any spares purchased and price must include markup.

The service provider must always be available on weekends, public holidays and peak season (December holidays). The repairs and maintenance of pump system shall comprise labour and material/parts necessary for carrying out the works on the following pumps:

1. Submersible pumps
2. Centrifugal pumps (mono pumps)
3. Solar pumps (i.e. including panels)
4. Pool pumps (Including filters)

2. Replace all filters (e.g. oil filters, air filters etc.)
3. Check and replace oil and greasing movable parts
4. Replacement parts
5. Consumables
6. Checking pumps electrical control systems including solar
7. Checking mechanical seals
8. Checking condition of bearings
9. Check leakages on engine and pump
10. Check and repair engine frame and mounting
11. Service provider must have a local office/workshop within 150km from the AENP.
12. Compile and submit all technical information on a specific borehole (depth, pump details, yield of borehole)

ASSIGNMENT AND SUB-CONTRACTING

- The service provider will not assign or subcontract any part of the contract

INDEMNITY

- The successful tenderer shall be deemed to have indemnified SANParks and shall keep SANParks indemnified against all actions, proceedings, claims, demands, damages and expenses which may be levied or made against SANParks, or which SANParks may sustain or incur by reason of any injury to persons or property, arising directly or indirectly out of any action by the successful tenderer or his agents in the execution of the tender.
