DETAILED TECHNICAL SPECIFICATION

1. COMPANY OVERVIEW

South African Broadcasting Corporation (SABC) is a Public Entity founded in August 1936 and listed in terms of Schedule 2 of the Public Finance Management Act, Act No. 1 of 1999, as a public broadcaster in South Africa, and provides 19 radio stations as well as five television broadcasts to the general public.

2. BACKGROUND

In the SABC, Auckland Park, there is a number of assets that have been classified as redundant, these are miscellaneous assets, including BIT Infrastructure. It was also agreed that the following method of disposal will be followed, assets that are no longer in a usable state will be disposed by issuing an enquiry to the market and appoint the Supplier to offer a financial offer and purchase the whole lot from SABC.

3. SCOPE OF WORK

- a) Sorting, Recycling, and collection of assets at SABC
- b) Give an offer on the assets.
- c) Service provider will be required to dispose any unwanted items as waste, in environmental friendly manner.
