1. PURPOSE

The purpose of this RFQ is to appoint a suitable qualified service provider to provide to provide expansion of existing audio-visual technology to a collaboration meeting space and maintenance and support of existing Audio-Visual System for a period of three (03) years.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

Upgrade / Solution Specifications:

Components Upgraded and Incorporated:

- Replace existing projection screens with new projection screens and expand with an additional presenter preview screen.
- Upgrade existing projectors to laser projectors and expand to include presenters preview screening.
- Expand system with new user interface that is a high-definition AV presentation solution.
- Inclusion of a Bring-Your-OWN Device [BYOD] wireless conferencing capability.
- New USB-Switcher
- Incorporation of new Videoconference system
- Inclusion of a new touch control panel

The solution consists of the following components:

DISPLAY UPGRADE AND EXPANSION OF EXISTING DISPLAY TECHNOLOGY

- i) Expanding the existing configuration to include an additional 110” automated projection screen to serve as a presenter’s preview screen above the entrance-way to the boardroom in direct line of sight from the existing podium.
- ii) Remove the existing projection screens and projectors and replace with new 135” [16:10] wide screen projection screens.
- iii) Replace existing two and expand by an additional one – new Epson 6,000 lumens WXUGA laser projectors or Equivalent

INCORPORATION OF USER INTERFACE

- i) Integrate surface mounted transmitter and receiver – Extron HC 400 Series or Equivalent for meeting space collaboration, HCT 103 transmitter and HCT 102 receiver or Equivalent, allowing laptop and mobile devices to be connected to one of the three inputs at the podium and routes the signal to the projectors.
- ii) Include the Barco Clickshare CX20 or Equivalent for wireless conferencing that allows automatic connection to the rooms devices making hybrid meetings easy and quickly accessible.
- iii) Integrate the Extron SW USB Series four input USB Switcher or Equivalent allowing multiple host devices and USB peripherals.

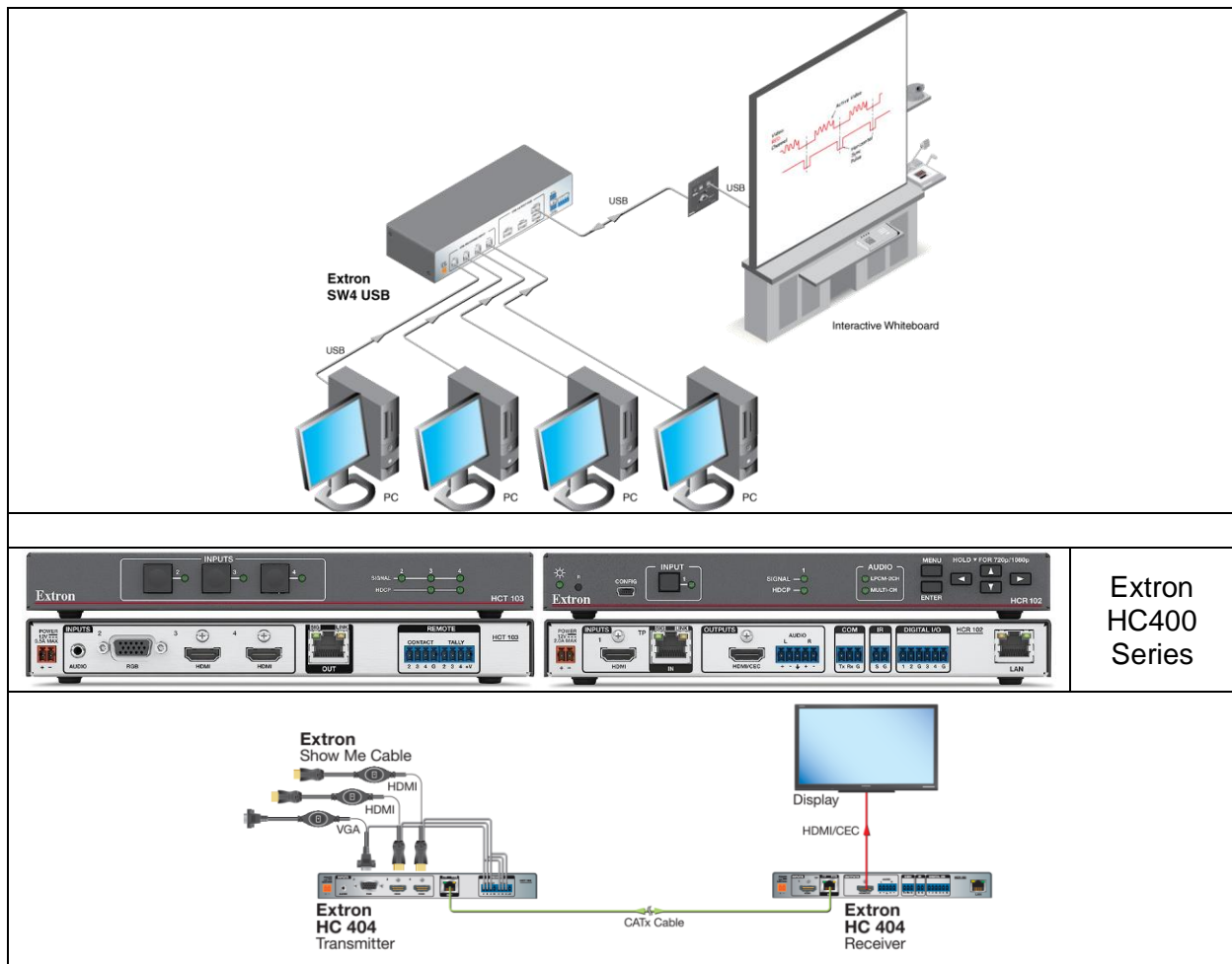
VIDEO-CONFERENCE INTEGRATION

- i) Install the Poly G7500 or Equivalent with 2 x dual E70 camera's or Equivalent and a single 12 x Zoom PTZ Camera.
- ii) The 12 x Zoom PTZ camera is positioned for the presenter at the podium.
- iii) Incorporate the Poly TC10 or Equivalent touch control panel with the 10" high resolution touch display that is integrated with the Extron or Equivalent for added AV controlling the lighting etc.

- i) Remove and replace existing microphone system with new Televic Discussion Delegate units [23] – Confidea F-DD or Equivalent.

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

$$Ps = 80 \left(1 - \frac{Pt - Pmin}{Pmin} \right)$$

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmin = Price of lowest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear the 80/20 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that the 80/20 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that the 80/20 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for the 80/20 preference point system.
