## **1. INTRODUCTION TO THE NRF**

### 1. SAAO Sutherland Site Visit:

- Bidders are invited for a **compulsory site visit** on the 8<sup>th</sup> of October 2025.
- Transport from **Cape Town Observatory** to the **Sutherland Observatory** will be arranged, along with **accommodation for 1x representative** from each bidding contractor.
- **Interested bidders should confirm whether they will be using our transport and accommodation by Monday, 29 September 2025 @ 15:00**
- Transport will leave from Cape Town on Tuesday, the 7<sup>th</sup> of October at 10:30 for Sutherland, and return to Cape Town on Wednesday, the 8<sup>th</sup> of October.
- Interested bidders are welcome to use their own transport and arrange their own accommodation, for the site visit, **at their own expense**.
- The site walkaround will be conducted the Wednesday morning at 08:00 until the transport leaves for Cape Town.
- Contractors are welcome to bring small fibre testing equipment, such as an ODTR, with them to the site visit to determine the state of the fibres that are down.
- More info on the site fibres provided under section 2 below.

## 2. Quotation For Optical Fibre Repairs:

- Interested bidders must provide us with a quotation to repair the fibres that are currently faulty.
- All work must be specified in detail. This includes, **but is not limited to**, labour cost, repair or resplicing of optical fibres or replacement of optical fibres, equipment hire, consumables, travel and accommodation, etc.
- On-site accommodation is available and costs will be provided to interested bidders.
- An OTDR report for each specified link (in-depth details below) is compulsory after work is conducted to determine the current state of each fibre link.
- Fibres from the Visitor Centre to the Houses must be repaired.
- The fibre from the Visitor Centre to the RecCentre must be repaired.
- Fibres that got unhooked from the poles on site must be fixed and secured.

### 3. Installation of two new fibres:

- Two new fibres need to be installed from the Datacentre to the Water Reservoir as will be indicated below.
- Fibres need to be 150m each. There will be a conduit available for each fibre.
- Fibres need to be 4-Core OM4 Multi-mode each.
- Fibres has to be terminated at each end inside a patch panel.
- 2x 19inch rack mounted 1U patch panels should be provided for the installation inside the DataCentre and inside a 6U cabinet at the Water Reservoir.
- LC-LC Duplex UPC Multimode mid-couplers for each fibre are required to be installed inside the patch panels.
- Labelling of the all fibres at each end.
- OTDR report for each fibre after work has been completed.
- All associated costs (installation, termination, test etc...) need to be included in the quotation.

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and

1.2 **To be completed by the organ of state**

- a) The applicable preference point system for this tender is the **80/20** preference point system.



- b) The **80/20 preference point system** will be applicable in this tender. The lowest/highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 **To be completed by the organ of state:**

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

(e) “the Act” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
