In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for the **PROVISION OF SECURITY SERVICES AT GOVAN MBEKI MUNICIPALITY PREMISES IN REGION 3 (EMBALENHLE AND CHARL CILLIERS) FOR THIRTY-SIX (36) MONTHS**

Tender documents and specifications are available and will ONLY be sold at a non-refundable fee of R1000.00 from the 11^h of November 2024. Tender documents will be sold at the Cash Point by the Cashier's at the head office in Secunda.

The closing time for receipt of tenders is **12:00hrs on 09/12/2024**. Telegraphic, facsimile, e-mail, unmarked and **late tenders** will under no circumstances be considered and accepted. The tender box will be emptied just after closing time on the closing date. Hereafter all bids will be public.

Fully completed tender documents, clearly marked **Tender No. 8/3/1-15/2023: “PROVISION OF SECURITY SERVICES AT GOVAN MBEKI MUNICIPALITY PREMISES IN REGION 3 (EMBALENHLE AND CHARL CILLIERS) FOR THIRTY-SIX (36) MONTHS”** with **“NAME of TENDERER”** must be placed in a sealed envelope and placed in the tender box provided by Govan Mbeki Municipality on the 1st floor, Horwood Street, Secunda, 2302 by no later than 12h00 on **10/12/2024**. The envelope must be endorsed with number, title and closing date as indicated above.

*A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No. 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Govan Mbeki Municipality where **80** points will be allocated in respective of price and **20** points for a specific goal. Govan Mbeki Municipality Supply Chain Management Policy allocate **20** points as follows:*

- *race (HDI) (6);*
- *people with disability (4)*
- *youth (4);*
- *woman (4); and*
- *Implementing reconstruction and development program (2).*



No awards will be made to a person:

- Who is not registered on the Central Supplier Database;
- Who is in the service of the state;
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

Bidders that do not hear anything after three (3) months from closing date of this tender, must consider their bids as unsuccessful.

The following documents must be attached as Annexure (Bidders that fail to submit documents indicated as compulsory will be disqualified)

- **Copy/ printed Tax compliance status Pin to enable the municipality to verify the bidder's tax compliance status- Compulsory**
- **Copy of bidder's current municipal account (not older than 3 months) or copy of valid Lease Agreement – Compulsory**
- **Valid CSD summary report – Compulsory**
- **Valid 6 months Police Clearance Certificate of Company Directors - Compulsory**
- **Certified company registration with PSIRA in terms of section 21 of the Private Security Industry Regulations Act 56 of 2001 – Compulsory**
- **Certified copy of PSIRA registration certificate for company directors – Compulsory**
- **Valid PSIRA Inspection report not older than 12 months - Compulsory**
- **Public liability Insurance (minimum R 15 million) – Compulsory**
- **Valid COIDA certificate/Letter of good standing - Compulsory**
- **Certified ICASA approved certificate for two-way radios – Compulsory**
- **Audited annual financial statements for the past 3 years for Bid above R10m for Bidders required by law to submit Annual Financial statements – Compulsory**

FORGERY OF DOCUMENTS

- **Bidders that are found to have submitted forged or false documents as stipulated above, will not just be eliminated, but will also be reported to National Treasury and backlisted from doing business with the Municipality.**
- **Those bidders will be listed on National Treasury database of restricted service providers from doing business with Government.**
- **Fraud and criminal cases can also be opened with SAPS.**
- **Bidders are therefore advised and encouraged to submit true and correct documents.**
