 - (c) On the bridge size, keep it as 24m long X 4m wide (heavy duty at least 80 tons load). Due to the size required, on site certificate of weight will be required. Provision in costing must be included for such on site testing.
 - (d) The weight bridge must be a stand-alone full solution, with its own software. No integration outside the bridge full solution (bridge & software) is required.
