**Expression of interest (EOI)** to indicate your interest in the provision of a warehouse facility for acquisition (Not Leasing) by Eskom Distribution Division within the Gauteng province.

## 1. BACKGROUND:

Eskom Distribution, a division of Eskom Holdings SOC Ltd, is responsible for the delivery of electricity across South Africa. The Procurement & Supply Chain function manages the logistics and distribution of electrical materials and equipment essential to Eskom’s operations nationwide.

Eskom Distribution operates:

- **17 Regional Distribution Centres (RDCs)**
- **Over 325 Customer Network Centres (CNCs)**

To enhance logistics efficiency and service delivery, Eskom Distribution is considering the establishment of a **National Distribution Centre (NDC)**. The preferred location for the NDC is **Gauteng Province**, serving as a central hub for RDCs and, where applicable, direct deliveries to CNCs and project sites across South Africa. The proposed facility is expected to be fitted with all the necessary equipment, technology, tools and any required resources to effectively operate a facility of this nature.
