Note1:

- Transnet will provide office space with telephone numbers for office-based employees (Facilities manager, Technical and Non-technical coordinator, Safety Coordinator and help desk personnel)
- Only the Facilities Manager, Technical and Non-technical coordinator will have cell phone access to communicate with stakeholders, etc.

Note2:

- The contract value will be awarded based on competitive Fixed costs which are predetermined as per specification Annexures issued and on-site labour requested to attend to day-to-day maintenance requirements only.
- The price offered must be based on the required personnel, specification, intervals, quantities, and intervals indicated on this tender document, specification, and SLA. It must also include consumables, tools, equipment and labour, supervisors, and all required resources to provide facilities management and facilities services.
- Transnet Property (TP) will reserve budget separate from the contract for unplanned or unforeseen costs herein referred to Variable or Pass-Through costs. These variable costs will be outsourced by TP, paid through the service provider and handled by means of a management fee.
- Services performed through Variable costs outsourced to 3rd party service providers include nut not limited to labour, spares and material outside of the fixed costs.
- The management fee will be charged on a fixed premium of not more than **12%** of the outsourced value (Percentage to be finalised during award negotiations).
- Transnet intends <u>not to</u> escalate the contract value more than yearly inflation for the contract period (3 years), therefore <u>Bidders are required to quote on a yearly basis</u> inclusive of the estimated possible escalations over 3 years.
- All salaries quoted must be in line with statutory or Government gazetted rates where applicable or be comparable with the industry norm or rates over 3 years. (Refer to **Annexure E**)
