6. EVALUATION CRITERIA

Nkandla Local Municipality subscribes to the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000). The 80/20 preference points system will be applicable during the evaluation and adjudication of this bid. The amended PPPFA regulation 2022 will be used. **The detailed evaluation criteria will be available on the Tender document.**

STAGE 1: COMPLIANCE TO MANDATORY

STAGE 2: FUNCTIONALITY

Bids will be subject to a prequalification in terms of functionality, thus: Functionality, 100 points (Minimum threshold of 70 points) being 60 points for Experience & 40 points for capacity.

STAGE 3: PREFERENTIAL POINT SYSTEM

Preferential Points System (80/20); 80 for Price and 20 for specific goals. Only bidders who pass the second stage with a minimum of 70 points will then be evaluated further in the third stage.
