1.1. Measurement and Payment

The activities listed by the *Employer* are the minimum activities acceptable and identify the specific activities which are required to achieve Completion. The Pricing schedule work breakdown structure is compiled to the satisfaction of the *Project Manager* with any additions and/or amendments deemed necessary.
- 1.2.4 The *Contractor's* detailed Pricing Schedule summates back to the Pricing Schedule provided by the *Employer* and is in sufficient detail to monitor completion of activities related to the Accepted Programme in order that payment of completed activities may be assessed.
- 1.2.5 The short descriptions in the Pricing Schedule are for identification purposes only. All work described in the Works Information is deemed included in the activities.
- 1.2.6 The Pricing Schedule is integrated with the Prices, Accepted Programme and where required the forecast rate of payment schedule.
- 1.2.7 Activities in multiple currencies are separately identified on both the Pricing Schedule and the Accepted Programme for each currency.
- 1.2.8 Plant to be supplied (Wet rates, i.e., include oil and fuel.)
- 1.2.9 Rate must include plant operators and their assistants.
- 1.2.10 Labour rate to include PPE, cleaning equipment and disinfectant products.
