DETAILED TECHNICAL REQUIREMENTS

2. BACKGROUND

The South African Broadcasting Corporation (SABC) is South Africa's national broadcaster. Its objectives are to provide a comprehensive range of distinctive programmes and services with the view to inform, educate, entertain, support and develop culture in all 11 official languages. Its principal activities comprise of television and radio broadcasting utilising 18 radio stations and 3 television channels.

The SABC NW has staff personnel capacity of about 177 people and additional of about 100 people made of office tenants. The SABC NW building has a full built-in canteen and kitchen facilities. The SABC had a 36 months contract agreement that ended in 2020. Currently the province does not have a valid contract agreement to render canteen and catering services.

In order for the province to fulfil its obligations optimally, SABC need to engage and make use of the service provider to offer services of canteen and catering. The successful bidder will render service for the provision of food, beverages and similar related service. The service provider is expected to take full responsibility of refilling gas bottles used in canteen. Services, terms and conditions will be stipulated in the RFQ document.

3. REQUIREMENTS AND SCOPE OF SERVICES

The catering services will be rendered as follows:

3.1 Daily catering for staff

The service provider will be required to prepare and serve adequate food to the SABC staff and tenants from Monday to Friday, excluding public holidays. The average number of staff who utilises the canteen on daily basis will be between 50 and 100 (freelancers and contractor employees included). The figure is based as per the previous canteen operation.

The requirements for staff catering are as follows:

3.1.1 Breakfast

Breakfast must be served from 06:30am until 10:30am (seated and takeaways). Breakfast service includes hot and cold items: examples - fried

eggs, boiled eggs, sausages, toasted sandwiches, fried tomatoes, loose seasonal fruit, soup, porridge, slices of bread (brown & white bread), hot and cold cereals, yogurt, fruit salads, muffins, tea, coffee, cappuccinos, etc.

3.1.2 Lunch

Lunch must be served from 12:00pm until 15:00pm (seated and takeaways). The options service to include hot items: minimum 2 protein, 2 starches/ carbohydrates, vegetarian, loose seasonal fruit assorted warm and cold drinks.

3.1.3 Healthy Bar

Healthy Bar is served throughout the operating hours, i.e. 06:30 to 16:00.

Within the canteen area is a Health Bar that serves fresh juices, smoothies, health and fruit platters, loose seasonal fruit, health bars, health muffins etc. and all tea and coffees.

3.1.4 Coffee Bar

Coffee Bar will be served throughout the day, i.e. 06:30 to 16:00.

Within the canteen area is a Health Bar that serves **coffees**, fresh juices, health bars, health muffins and all teas is required.

3.1.5 Evening & Weekend Operations

Evening and Weekend services will be arranged with the SABC for special events and functions.

.4 Subsidy Scheme Structure

4.1 The SABC will offer canteen facilities rent free, as well as water and electricity for free.

4.2 The SABC will provide equipment including maintenance of the equipment.

4.3 SABC events and functions will not be subsidised.

4.4 The service provider will be expected to charge the meals at prices set together with the SABC in lieu of the rent free, equipment provision arrangement and

management fee. The SABC may dictate that an affordable balanced meal be made available at a negotiated set price.

The services rendered will be for successful tenderers own account, taking responsibility for all the risks including profit / loss, stock and cash control. The caterer will be expected to render a service for the provision of food, beverages, services, etc.

It will be required from the successful tenderer to also stock a range of goods as required the employees i.e cold drinks fruit, yoghurt, chips, sweets, cigarettes, airtime etc

The contract will be for a period of 36 months. In the event of unsatisfactory service rendered by the successful tenderer, SABC reserves the right to terminate the contract at any given time, with one month notice.

The successful bidder will not be permitted to use the SABC premises/facilities to cater for other parties except for the SABC staff and visitors only

The Canteen Staff must be presentable, wearing uniform and protective clothing.

Special catering

Special catering for the SABC and visitors will be requested when there is a need and generally with ample notice. The canteen provider will be notified prior to the visit of groups, usually 1 week in advance.

Note that the SABC is open for proposals within each category.

Payments

Payment by the SABC to the contractor shall be made 60 days in arrears after an invoice from the contractor is received by the SABC.

5. RFQ Validity period

This bid will remain valid **90 (ninety) days** from the date of bid closing.

6. Costing

The indicative costing should reflect a detailed cost breakdown, and any direct or indirect costs associated with the rendering of required services.

11.3 ADJUDICATION USING A POINT SYSTEM

- The bidder obtaining the highest number of total points will be awarded the contract.
- Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

11.4 Objective Criteria

- The SABC reserves the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- The SABC will not award contract/s to the bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, company financials, etc. will be eliminated from the bid process.
- The SABC reserve the right not to award this tender to any bidder who fails the financial stability assessment.
- No SABC former employees shall be awarded contracts with the SABC within 24 months after termination of employment with the SABC.
- Should employees resign or retire from the employment of the SABC and become directors of other businesses tendering with the SABC, such tender shall not be considered until the cooling off period of 24 (twenty-four) months has expired.
- Should the employee be dismissed from the SABC employment, such employee shall be prohibited from conducting business with SABC for a period of 5 (five) years from the date of dismissal.
- Should the employee be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.
- The SABC shall not procure any goods, services, works or Content from any Board member or Board member owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.
- Should the SABC's Board members no longer serve on the SABC Board but become directors of other companies, the SABC shall not conduct business with those companies until the cooling off period of 24 (twenty-four) months has expired.
- Should the Board member be found guilty in a court of law due to criminal conduct/act, such Board member will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.
- The SABC shall not procure any goods, services, works or Content from any independent contractor or independent contractor owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.
- Should the Independent Contractor no longer be contracted to the SABC but become directors of other companies, the SABC shall not conduct business

with those companies until the cooling-off period of 24 (twenty-four) months has expired.

- Should the Independent Contract be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.

12 COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

13 CONDITIONS TO BE OBSERVED WHEN TENDERING

- The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification.

The corporation also reserves the right to withdraw the tender at any stage.

- No tender shall be deemed to have been accepted unless or until a formal contract / letter of award is signed by both parties.

- **The Corporation reserves the right to:**

- Not evaluate and award submissions that do not comply with this tender document.
- Make a selection solely on the information received in the submissions.
- Enter negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
- Contact any bidder during the evaluation process, to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered, or permitted.
- Award a contract to one or more bidder(s).
- Accept any tender in part or full at its own discretion.
- Cancel this RFQ or any part thereof at any time.
- Should a bidder(s) be selected for further negotiations, they will be chosen based on the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BEE & Price.

14 Cost of Bidding

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under any circumstances be responsible or liable for any such costs, regardless of, without limitation, the outcome of the bidding, evaluation, and selection process.

15 PAYMENT TERMS

SABC will effect payment sixty (60) days after the service provider has rendered the service and submitted an invoice / statement.
