SCOPE OF WORK

1. Background

The Maphumulo Water Works will be upgraded from 6Ml/day to 12Ml/day in Phase 3. Therefore, the purpose of this project, Maphumulo Phase 4, is to augment the Imvutshane Dam with 6Ml/day of raw water from the Hlimbitwa River in order to have sufficient supply for the Water Works upgrade.

Maphumulo Phase 4 comprises of the following infrastructure:

- 3-notch abstraction weir
- Gravel trap with a radial gate for flushing and sluice gate for isolation during maintenance of the radial gate.
- Sand trap canals with a trash rack, screens and sluice gates.
- Pump station
- Horizontal split case pumps (one stand-by, one duty) and associated steel pipe work
- Lifting equipment
- MCC
- 1,1km long 450mm ø HDPE pipeline and associated appurtenances.
- 0,9km asphalt paved access road
- Associated electrical power supply and back-up generator
- Associated instrumentation

The proposed project is located on the Hlimbitwa river approximately 26km from Maphumulo town under Maphumulo Local Municipality and ILembe district Municipality in Kwa Zulu Natal. The project location of abstraction works site (29°12'37.63"S 31°01'24.03"E).

2. Description of services required

2.1 Scope

UUW intends to establish if reliable communications for SCADA and Telemetry applications for the Maphumulo Pump Station are feasible, through this radio frequency path study. The telemetry Contractor shall do path calculations to select the best frequency route.

The telemetry Contractor shall cover the following:

2.1.1 Supply and study radio path network user bandwidth calculation and submit a report to uMngeni-uThukela water.

2.1.2 Populate report cover:

- a) Location point to point
- b) Repeater requirements

- c) Antenna heights, type, and gain
- d) Installation, data gathering, analysis, equipment, and recommendations
- e) Network and radio frequency
- f) Summary and results

2.2 Technical Specification

2.2.1 Radio Study:

The radio frequency study using professional propagation software

Location point-to-point

The radio study path shall be studied from the Maphumulo pump station to the Maphumulo SCADA server.

2.2.2 Repeater Requirements:

If required by radio study, the Telemetry constructor shall determine the model repeater requirement based on UUW specifications.

2.2.3 Installation, data gathering, analysis, equipment, and recommendations

The contractor shall report and recommend equipment to be used for telemetry and its installation step by step.

2.2.4 Network and Radio Frequency

Radio communication or radio frequency communication refers to wireless communication through the air with electromagnetic wave frequencies ranging from 3 kHz to 300 GHz. The contractor shall give the UUW frequency range that will be used for communication and real-time data transferred.

2.3 Work Instruction

2.3.1 General

2.3.1.1 The Contractor shall study the documentation supplied and comment on the bill of materials.

All traveling and subsistence costs involved in the execution of this work shall be included in the price rates.

2.3.1.2 This is a firm and fixed-price contract and the Contractor is to bear in mind that no additional work will be paid for unless it is in response to a written request from Umgeni Water Project Leader.

2.3.1.3 The Contractor shall bear in mind that they will be working in clean, potable water pipelines, and a high level of hygiene shall be observed and maintained by all persons working on site.

2.3.1.4 All people working on site shall not use water from the channel or from the tap which has a warning sign on it. Usage of this unsensitised water will result in to severe diseases.

2.3.1.5 The Project Leader shall be entitled, during manufacture, to inspect, examine and test the materials and workmanship and check the progress of manufacture of all plant to be supplied under the Contract. This shall take place on the Contractor's premises during working hours. If the plant is being manufactured on other premises, the Contractor shall obtain permission for the Project Leader to carry out such inspection, examination, and testing on those premises.

2.3.1.6 No such inspection, examination, or testing shall release the Contractor from any obligation

under the Contract.

2.3.2 Site Assistance

- The engineering work will be under the supervision of uMngeni-uThukela Water's EA. The Project Leader shall have the power to give instructions for the removal and/or re-execution of any engineering work not in accordance with the contract.

2.3.3 Inspection of the site

- It shall be a condition of this contract that in submitting a quote, the Contractor will be deemed to have visited the site and to have considered all factors relating thereto which could influence his quote and no claims for additional payment on the grounds of insufficient and or inaccurate information will be entertained. Any additional work deemed necessary and not included within the scope may be agreed upon during the site inspection and will be included as an addendum to the scope of work of this document

2.3.4 Training

- The Contractor shall facilitate an onsite training after or during the installation and the training shall be facilitated to 3 delegates from Umgeni Water. The training shall cover the following:
 - Radio study path

2.3.5 Setting Out

2.3.5.1 The Contractor shall set out the works in relation to original points, lines and levels of reference given by the Project Leader in writing, provide all necessary instruments, appliances, and labour for such purposes.

2.3.5.2 If, at any time during the execution of the works, any error appears in the positions, levels, dimensions or alignment of the works, the Contractor shall rectify the error.

2.3.5.3 The Contractor shall bear the cost of rectifying the error, unless the error results from incorrect information supplied in writing by the Project Leader or from default by another contractor, in which case the cost together with profit shall be borne by Umgeni Water.

2.3.5.4 The checking of any setting-out by the Project Leader shall not relieve the Contractor of his responsibility for the accuracy thereof.

2.3.6 Alteration to Programme

- No material alteration to the Programme shall be made without the approval of the Project Leader.

2.3.7 Revision of Programme

- If the progress of the works does not conform to the Programme, the project Leader may instruct the Contractor to revise the Programme.
- If such modifications are required for reasons for which the Contractor is not responsible, the cost of preparing the revised Programme shall be certified by the Project and added to the Contract Price.

2.3.8 Clearance of Site

The Contractor shall from time to time during the progress of the works clear away and remove all surplus materials and rubbish. On completion of the works, the Contractor shall remove all Contractors' Equipment and leave the whole of the site and the works clean and in a workmanlike condition, to the satisfaction of the Project Leader.

2.3.9 Manner of Execution

- All Plant to be supplied shall be manufactured and all work to be done shall be executed in the manner set out in the Contract.
- Where the manner of manufacture and execution is not set out in the Contract, the work shall be executed in a proper and workmanlike manner in accordance with recognised good practice.

2.3.10 Covering up Work

- The Contractor shall give the Project Leader full opportunity to examine, measure and test any work on site which is about to be covered up or put out of view.


