

## **TENDER REQUEST**

**CKDM001 – 2023/2024:** The supply, delivery and offloading of Refined Bulk Fuel, for a period of three (3) years, to three CKDM depots, located in Beaufort West, Laingsburg, and Prince Albert on a "as and when required" basis.

**CKDM002 – 2023/2024:** The appointment of a PSIRA registered service provider to render security services for a period of three (3) years within the Central Karoo District.

**CKDM003 – 2023/2024:** Supply, delivery, and physical offloading of Fine aggregate (sand) at the Central Karoo District Municipality's depots for a period of one (1) year.

Tenders will be evaluated and adjudicated on the Preferential Procurement Regulation of 2022 and the Central Karoo District Municipality Supply Chain Management Policy, where 80 points will be allocated in respect of price and 20 points in respect of B-BBEE and locality. Bidders must be registered on the Central Supplier Database.

Tenders must be sealed and externally endorsed with the relevant tender number and description and placed in the Tender Box at the offices of the Central Karoo District Municipality (opposite ABSA bank), at 63 Donkin Street, Beaufort West not later than the closing dates as indicated above, when it will be opened in public at the offices of the Central Karoo District Municipality.
