## **REQUEST FOR QUOTATION: GAS SUPPLY FOR A PERIOD OF 3 YEARS.**

### **1. BACKGROUND TO SANSA**

The South African National Space Agency (SANSA) has a mandate, as outlined in the South African National Space Agency Act, 2008 (Act No 36 of 2008), to co-ordinate and integrate national space science and technology programmes and conduct long-term planning and implementation of space-related activities in South Africa, for the benefit of the citizens of South Africa

### **2. SCOPE OF WORK (TERMS OF REFERENCE)**

Three-year contract for the supply and exchange of gas cylinders of various compressed gasses on site.

A Three- year contract with an accredited Gas supplier for the supply and exchange of monthly rented Gas cylinders as needed. We make use of nine (9) Big Compressed gas cylinders on site that needs to be exchanged as needed.

Sansa currently owns four small Portapak gas cylinders and requires an additional four cylinders (two oxygen) and (two Acetylene) portapak cylinders that needs to be exchanged when empty as and when needed.

The four new additional Portapak cylinders must be supplied with the start of the contract, but after the supply of the new cylinders no additional Portapak cylinders will be needed for the duration of the contract.

This will bring the total number of Sansa owned Portapak cylinders to eight ( 8 ) , four Oxygen and four Acetylene cylinders that must be exchanged with full cylinders when required.

SANSA promotes the concept of “best value” in the award of contracts, as opposed to merely looking for the cheapest price, which does not necessarily provide the best value. Best value incorporates the expertise, experience and technical proposal of the organisation and individuals who will be providing the service and the organisational capacity supporting the project team.

SANSA is committed to achieving Government's transformation objectives in terms of the Preferential Procurement Policy Framework Act.

The value of this bid is estimated not to exceed R1 million (all applicable taxes included) and therefore the **80/20** system shall be applicable.

**Please Note: the above amount (R1 million) is not the budgeted amount for this project, but it is the Treasury threshold for written price quotations.**

The procedure for the evaluation of responsive tenders is **Price** and **Preference** method.

Bids will be evaluated in terms of the 80/20 preference points systems, where the 80 points will be used for price only and the 20 points will be awarded to a bidder for attaining the specific goals in accordance with the Table below.
