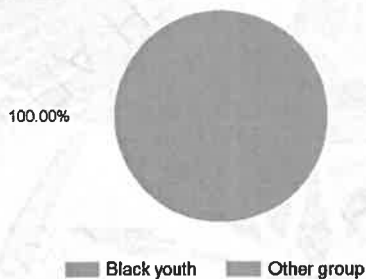
People % Ownership



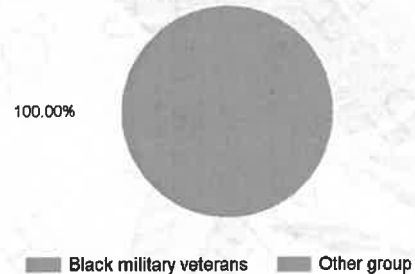
Gender % Ownership
