1. OUTLINE

These Terms of Reference outline the minimum Scope of Work for which the PSP is responsible. It defines key accountabilities and what the PSP is responsible for delivering i.e. the required outcomes as a result of the civil activities.

2. BACKGROUND

The Development planning Department within the municipality has the responsibility to provide a conducive environment for businesses to operate. The Municipality is endowed with agricultural development that some local communities rely on it for living. The Municipality have prioritised several projects under Farmers Development Program as a strategy of creating jobs for themselves and hence its inclusion on the LED Strategic plan as well as the Service Delivery and Budget Implementation Plan (SDBIP) to capacitate this sector. The programme is strictly fishing related. And therefore requests that the professional suitable bidders submit their proposal for supply & delivery of equipment and material for fisheries projects. On receipt of the appointment letter it is expected that the appointed service provider will sign with the municipal manager the service level agreement.

PURPOSE AND OBJECTIVES

Is to increase the level of production within the Oceans economy sector, to intensify food security where the intended outcome is to reduce high levels of unemployment and stimulate local economic growth and development.

SCOPE OF WORK OF THE APPOINTED SERVICE PROVIDER

The appointed service provider will be tasked to assist the municipality with the execution of the Mariculture Development programme: fisheries and beach infrastructure development projects across Mbizana. Moreover, the appointed service provider will be commissioned to delivery and supply fishing material and equipment to selected projects.

REPORTING

The appointed service provider shall submit weekly reports to the Municipality or Project Manager.

DURATION

Service providers must complete the project within (30 days)1 months from the date of appointment.

TRANSFER OF SKILLS

The service provider must have a clear empowerment plan that will prepare primary stakeholders to participate.

EXPECTED OUTCOMES AND PROGRAMME CONTRIBUTION

In line with the project scope, all activities are expected to be successfully completed accordingly and according to the time-frames in place. This programme massively contributes to the food security of Mbizana and as indicated above this programme largely contributed to the employment creation in the Mbizana. Additionally, the project also contributed to the development of local fisheries from small scale fisheries to commercial fisheries.
