The intent of this Request for Information is to:

- Invite interested suppliers to provide information for the Provision of Services to Upgrade SAAT Security Infrastructure.

1.1.2) Description of actual requirement:

Requested Solution Description:

SAAT is seeking information from suppliers with relevant experience on the Provision of the **UPGRADE OF THE SAAT SECURITY INFRASTRUCTURE**.

The main objectives of this project:

- To assess, inter alia, the option and Technology available for the upgrade of the security
- Establish which suppliers in the market can Provide a proposal of the detailed scope of Security Upgrade.
- Establish the potential costs requested Task
- Establish the number of vendors capable to provide the aforementioned service SAA Technical.

Service providers would be required to cover the following aspects in their proposals:

2.1	Provide a CCTV system which covers the whole SAAT campus including sterile areas in line with National Key Point Area.
2.2	Provide an access control system that would include capability for time and attendance with possible linkage to payroll.
2.3	Set up Security operational centre, The system and Provide CCTV screens for the security operational centre including SAAT security office..
2.4	The upgrading of the entire perimeter barrier to a minimum height of 3 meters and in compliance with the Minimum Physical Security Standards (MPSS)
2.5	The implementation of a perimeter intruder detection system specifically designed for aviation operations, to detect un authorised intrusion into the facility.
2.6	Upgrade illumination for critical, sterile and sensitive operational areas.
2.7	Provision and upgrading of the guard houses/huts which has a bullet resistant capability and in compliance with Minimum Physical Security Standard (MPSS)

2.8	Procurement of Scanners and Walk through metal detectors.
2.9	Revamping of reception area and creating entry/Exit point dedicated to employees only.

2. REQUEST FOR INFORMATION INVITATION

2.1 Request for Information Preparation

All cost in the preparation, presentation and demonstration will be for the account of the vendor. All supporting documentation and manuals submitted in response to this request for information will become SAAT's property unless otherwise stated by the vendor at the time of submission.

2.2 Confidentiality

The information obtained through this request for information will be regarded as confidential; however, SAAT does not accept liability for any information which may become public.

2.3 No binding Agreement

Prices submitted with the request for information are for information only and no vendor will be held to any price submitted. SAAT further reserves the right to contact individual vendors to obtain further information should this be deemed necessary.

2.4 Samples

Vendors may, as part of their response, submit samples of the products supplied by the vendor. Samples submitted will be returned to the vendor only on request.

3. REQUEST FOR INFORMATION DOCUMENTS

3.1 Document requiring completion and return

Vendors must complete and submit the following documents as part of their response:

- a) prescribed request for information documents
- b) any information required in the request for information

3.2 Amendment of documents by SAAT

SAAT may, at any time prior to the deadline for lodging request for information, amend of the documents or extended the time for lodging documents by notice in writing to the prospective vendor/s. (Any amendments under this clause will become part of the request for information).

4. PREPARATION OF REQUEST FOR INFORMATION

4.1 Language of document

The request for information and all correspondence and documents related to the request for information exchanged by the vendor and SAAT shall be written in the language stipulated in the documents and conditions of the request for information.

Where necessary SAAT may assist is in the translation of any document if that document is not clear to the vendor.

4.2 Quality Assurance

4.2.1 Quality management systems

The vendor must supply the following information as part of its document:

- a) the vendor's quality policy, objectives and program, including, without limitation, a description of the method to be used by the vendor to ensure the quality of the product;
- b) the certification level of its QMS to be appropriate ISO standard (e.g. ISO 9001, ISO 9002).
- c) the name of the certifying body for the vendor's QMS;
- d) the scope of certification for the vendor's QMS; and
- e) the vendor's QMS certification license number
