Subject: Clarification on Submission and Return of Samples (Safety Boots, Gloves and Conti Suits)

In response to enquiries from bidders regarding the submission and possible return of samples, the IDT issues the following clarification:

1. Submission of Samples

- Samples are requested for evaluation under functionality/ quality criteria of the bid.
- Submission of samples contributes towards functionality scoring but is not a mandatory requirement for responsiveness.
- Samples must be clearly marked with the bidder's name and the bid number.

2. Ownership of Samples

- All samples submitted shall become the property of the IDT.
- Samples will be used exclusively for the purpose of verifying quality, durability and compliance with specification.

3. Non-return of Samples


