TERMS OF REFERENCE & REQUEST FOR QUOTATIONS

PROCUREMENT OF A PUMP FOR THE INDIAN VILLAGE PUMP STATION

1. Introduction:

As a bulk water supplier, it is the intention of uThukela Water to request quotations from suitable suppliers for the supply, delivery and installation of a Mather & Platt pump that is required for the Indian Village pump station.

2. Background:

The Indian Village pump station is situated next to the Kilbarchan village approximately 20kms from Newcastle. Potable water is pumped from the Ngagane Water Purification Plant to the Kilbarchan reservoir. The Indian Village pump station pumps water from the reservoir to the Indian Village community.

3. Requirements:

To supply, deliver, install, and commission a Mather & Platt pump at the Indian Village pump station.

DESCRIPTION:
1. Mather and Platt pump, type: AD 40/20, Bronze impeller 195mm diameter, complete with Mechanical seal and coupling. Pump is to be installed and commissioned. Modify existing pipework and base if required.
2. Quantity: One (1) off
Notes: <ul style="list-style-type: none">- Quotation is to include: The supply, delivery, installation, modifications and commissioning of a pump at the Indian Village pump station.

4. Quotations must be submitted in one of the following ways:

- Bids will be adjudicated in terms of the Preferential Procurement Regulation, 2022 pertaining to Preferential Procurement Policy Framework Act, 5/2000, UTW SCM Policy and other applicable legislations, and will be based on 80/20 points system. Preference points will be awarded to service providers using their B-BBEE status level of contribution.

- The municipal Entity reserves a right to accept all, some or none of the bids submitted, either wholly or in part and is not obliged to accept the lowest bid.
- National Treasury General Conditions of the contracts are applicable.
