DTPC wishes to appoint a panel of three (3) effective and efficient multidisciplinary professional service providers from suitably qualified and experienced Construction Claims Specialists to provide contract claim; litigation; and non-litigation/ alternative dispute resolution (ADR).

The specific objective of this invitation is to procure the services of a Construction Claims Specialist who will apply effective and best practice risk management techniques to optimise DTPC contractual and commercial position with respect to claims management and disputes.

The appointment of a Panel of Construction Claims Specialists will be for a period of three (3) years reckoned from the date of signing service level agreements with the DTPC.

Prequalification criteria

In line with the PPPFA regulations 2017, sub regulation 4 the prequalification for this bid is that:

- a) Only B-BBEE level 1, 2, 3 or 4 are eligible to tender.

EVALUATION OF THIS BID

All proposals will be evaluated in various stages – compliance and functionality will be assessed and thereafter all responsive proposals will be evaluated in accordance with the PPPFA regulations, 2017 using the 80/20 preference points system.
